Commissioner Bruce Berger (BB) and Deputy Commissioner Louis Vetrone (LV) updated the Env't. & Energy Committee at a November committee meeting. BB provided update on several entities – CRP (David Magel), A&D (Al Tranquillo III), and Earthline (transfer station at Croton, Regus). BB noted the recent sentencing of CRP manager David Magel and CRP's rejection of an SWC-ordered assignment of an independent auditor for the company. The County Attorney now represents SWC at the Supreme Court in this matter.			
Report on 2008: Highlight of dept's accomplishments (Usually in executive summary of dept budget)			
 SWC is working with WCDEF and Environmental Security Unit (ESU) of the Dept. of Public Safety as part of the administration recycling enforcement initiative. SWC has conducted meetings to inform trash haulers of the recycling enforcement initiative, which, according to SWC, has now become generally accepted by the industry. Other informational seminars have been provided to municipalities, school districts, and large waste generators (e.g., multi-unit buildings).

At 11/20 B&A review meeting, Chair Alvarado asked why several budget line items appeared inconsistent. The requested 2009 amounts significantly exceeded projected 2008 amounts (example – employee health

At 11/20 B&A review meeting, Chair Alvarado asked why several budget line items appeared inconsistent. The requested 2009 amounts significantly exceeded projected 2008 amounts (example – employee health insurance, supplies). Budget did not have a response. In one instance, BB stated that monies were being requested to accommodate a previous BOL request to retain forensic consulting services (for example, Contractual Services, Item 4380). BB stated that SWC was attempting to cut operating costs per the County Exec.'s directive (e.g., general supplies). BB stated that SWC is also seeking several Lexis Nexis inspections for inspectors to utilize in obtaining data. BB stated that relationship with trash haulers regarding recycling enforcement has improved, as haulers realize that SWC is tracing violations back to waste generators. Approx 33% of violations go to trash haulers, with half of this amount affecting private haulers (i.e., not municipal). SWC and DEF inspectors share information, data on entities. Most violations occur at transfer stations. Licensing fees for transfer stations are 'staggered' and can be reduced based on volume of recyclable material. (?) Transfer station licensing fee is \$20,000 per year; disposal facility (Resco) fee is \$50,000 per year.
