Mission Statement

The mission of the Department of Law, Office of the County Attorney, is to respond effectively to the needs of County officers, boards, departments and agencies, regarding legal counsel and representation. The County Attorney is charged by law to serve as legal counsel to the County Executive, the Board of Legislators, and to the County and all of its constituent departments, agencies and boards. The mission of the County Attorney is achieved in a variety of ways, including: the rendering of legal advice to County officials and employees in order to assist them on various projects the County is undertaking or contemplating undertaking; the preparation and review of legal documents; the drafting of legislation; the rendering of legal opinions, and the advocacy of the County's interests in trial and appellate courts, including special administrative proceedings. In providing legal services to the County, the Office of the County Attorney endeavors to reduce actual and potential future liabilities and financial exposure of the County and to maximize receipts of monetary sums to which the County may be entitled. The Office of the County Attorney seeks to assure that the County workplaces are free of discrimination and harassment and that County contracts and business opportunities are awarded fairly and openly, with women and minorities having equal access.

In addition the Office of the County Attorney seeks to protect the interests of children, disadvantaged adults, and society from domestic violence and abuse. Our Family Court Bureau acts to safeguard children from acts of abuse and neglect and to establish and collect child support from legally responsible parents. The Office of the County Attorney presents cases of juvenile delinquency to the Family Court in order to protect the public from dangerous juveniles and to rehabilitate juveniles in order to assist them in growing into productive members of society.



Tax Levy

Currently, the Law Department's approved Adopted budget for 2015 is \$10,930,336. The 2016 Law Department Budget proposes an expense budget of \$10,944,350, which is an increase of \$14,014 over the 2015 Adopted Budget. Our 2016 Budget proposes a negative tax levy of (-3,523,358).

Expenditures

Annual Regular (1010)

The 2016 Requested is a \$417,012 decrease from our 2015 Adopted Budget. This includes seven fewer positions.

Overtime (1400)

The 2016 Requested is \$500 which is the same as our 2015 Adopted Budget. This amount is based upon work performed by support staff on Election Day and the day after Thanksgiving, which are days the Law Department is required to work despite the County Offices being closed.

Replacement Equipment (2300)

The 2016 Requested is \$24,100 greater than our 2015 Adopted Budget due to the cost of McKinney's books.

Printing & Office Supplies (3600)

The 2016 Requested is the same as our 2015 Adopted.

Postage Cost (3700)

The 2016 Requested is a decrease of \$5,000 from our 2015 Adopted Budget.

Equipment Service & Rental (4070)

The 2016 Requested is a decrease of \$36,700 from our 2015Adopted Budget

Membership Fees (4100)

The 2016 Requested is the same as our 2015 Adopted Budget.

Travel & Meals (4110)

The 2016 Requested is the same as our 2015 Adopted Budget.

Telephone Expense (4160)

The 2016 Requested is a decrease of \$600.00 from our 2014 Adopted Budget.

OSHA Safety Program (4225)

The 2016 Requested is the same as our 2015 Adopted Budget.

Educational Training (4360)

The 2016 Requested is the same as our 2015 Adopted Budget.

Technical Services (4420)

The 2016 Requested is the same as our 2015 Adopted Budget. This expense includes the cost of the Labor Negotiator and Arbitrators. The breakdown of arbitration cases is as follows: 80% of our arbitration fees are attributable to contract grievance and disciplinary arbitrations held with COBA and its members (the other fifteen percent is attributable to SOA, PBA and CSEA contract grievances). In the cases of SOA, PBA and CSEA, the costs of the hearings are evenly split between the respective union and the County. In the case of COBA, the fees are split up to the point where the union has expended \$20,000 on arbitration fees in any given year. Once that threshold is met, the County assumes 100% of the costs for the remainder of that year.

Litigation (4923)

The 2016 Requested of \$818,000 is \$500,000 greater than the 2015 Adopted Budget.

<u>Interdepartmental Charges</u>

The 2016 Requested Budget is a decrease of t \$51,322 from the 2015 Adopted Budget. This is due largely to the reduction of IT charges.

Revenue

The Law Department's hourly rate charged to all County departments for law services for the current year is \$150.00. The calculated rate for 2016 budget is \$154.00. This hourly rate represents all billable hours produced by our Assistant, Senior and Associate County Attorneys, however it excludes all hours produced by the Assistant Chief Deputy County Attorneys, Chief Deputy County Attorney and County Attorney.

Interdepartmental Revenue (9508)

The 2016 allowed figure for Interdepartmental revenue for the Law Department is \$10,810,492. This represents an increase of approximately \$469,492 over 2015 estimates.


Departmental Revenue

The 2016 allowed revenue figure for Departmental revenue is \$2,874,102.

This is an increase of \$44,202 from 2015 estimates due to a decrease in the hourly rate to Risk Management, Environmental Facilities and Westchester Community College.

Introduction


The structure of the Law Department reflects the constant striving to fulfill its duties and responsibilities in the most efficient and responsible manner possible. The Law Department is divided into four bureaus, each of which is focused on the different components of the "Operation of the Law Department". In addition to the four Bureaus, the Department is responsible for the Office of Risk Management, which evaluates and reviews the County's risk exposure. The organization of the Department is summarized in the following chart:



The Department of Law occupies approximately 23,000 square feet of space, utilizing the entire sixth floor and a portion of the second and seventh floors of the Michaelian Office Building. The Department is in proximity to the County Executive's Office, the Board of Legislators, the Federal and County Court House Buildings, the District Attorney's Office and many of the other County Departments that it serves.

The Law Department's overall staffing level for 2016 has decreased for a total of 87 personnel. This number represents the number of authorized positions. The composition of the County Attorney's office is shown below.


Pursuant to Chapter 158 of the Laws of Westchester County, only the County Attorney and his staff are authorized to provide legal services to the County and its Departments.

While the Law Department Budget has been a partner is reducing its burden on the tax levy, it continues to provide all essential legal services. Very often, the most complicated matters are also the most time sensitive. Managing these matters requires maximum effort and commitment by staff, so that even as cases have risen and their complexity increased, all the necessary services have been provided. The results of these efforts show in the number of notable successes achieved thus far in 2015 by the Office of the County Attorney.

Revenues

The increase in case levels is evident in all bureaus and involves all legally mandated services, including but not limited to family court proceedings, litigation defense of the County, legislation, contract preparation and review, appeals and advisory opinions.

The Law Department generates two separate revenue streams:


- Departmental revenues are generated through charges billed to other funds including the 6-N Fund, Sewer, Water, and Refuse Disposal District Funds and the Westchester Community College Fund. This billing is generated as a result of legal services that are provided by the Law Department to these entities.
- Inter-Departmental revenues are received from County departments for which the Law Department performs essential legal services. Departments included in this revenue stream include the following: Public Works, Human Resources, Public Safety Services, Parks and Recreation, Planning, County Clerk, Department of Social Services, Community Mental Health, the Budget Department, Finance, the Department of Health, Information Technologies, Probation, Corrections, Transportation, etc.

These billing charges are based on the number of hours that each attorney spends providing legal advice, research or services for each of these Departments on various matters. Charges are based on hourly rates derived from the Law Department's operating costs and these rates are established each year in conjunction with the Budget Office when the County's Budget is prepared. The hourly rate is based on the Law Department's direct and indirect costs, while it excludes the usual and customary expenses incurred in representing our clients in such accounts as contractual services, technical services and litigation. The hourly rate for the current 2015 fiscal year is \$150.00 per hour.

The reason that billable hours are used both with cases handled by this Department and outside counsel is one of accountability and fiscal responsibility. The department being represented is then charged with monitoring their use of attorney's time much like private practice. It has also allowed the Law Department to clearly track the hours attorneys spend on various legal matters. In short, it is a system of checks and balances for legal work of the County.


Breakdown by Revenue Category



As indicated by the above chart approximately 17% of the Law Department service hours are not billable. This equates to approximately 17,180 hours of client services. This includes services provided to elected officials including the offices of the County Executive, the Board of Legislators and the District Attorney as well as statutorily mandated juvenile delinquency prosecutions. The County Attorney and the Deputies in charge of each bureau do not bill for direct client services or supervision, nor are their hours included in these figures. Notwithstanding the fact that the Deputy County Attorneys do not bill for their time, they are primarily responsible for providing legal advice directly to the Board of Legislators. The Assistant Chief Deputy County Attorney in charge of the Litigation Bureau appears before the Board's Committee on Budget and Appropriations on a regular basis with regard to case settlements, requests to initiate litigation and other various legal matters that require Board of Legislator approval. The Deputy County Attorney in charge of the Contracts and Real Estate Bureau frequently appears before various Board Committees with respect to contractual, affordable housing and energy issues. The County Attorney or his designee attends all of the regular and special meetings of the Board of Legislator and attends, as requested, various Board Committee meetings with regard to proposed legislation or other matters. Non-billable services also include all attorney time billed directly to the Law Department.

The vast majority of the Law Department's revenue that is billable comes from Inter-Departmental billing, which comprises 68% of the attorneys' work time or approximately 67,968 hours for the 2015 fiscal year. The second largest source of revenue for the Law Department is Departmental billing. Billing to Environmental Facilities, Public Utility Agency, Risk Management, Westchester Community College, and the Division of Solid Waste billing is considered Departmental billing. Each of these Departments contains their own separate funds and therefore their billing is maintained in a separate revenue stream than the Inter- Departmental billing. We estimate that the attorneys will spend approximately 14,982 hours on Departmental matters for the 2015 fiscal year or 15%.


Please be advised that this number represents only the work performed for the BOL by attorneys required to bill for their time. This number does not include the hours devoted to BOL work handled by the Assistant Chief Deputy County Attorneys, the Chief Deputy County Attorney and the County Attorney who do not bill for their time. Since a good portion of the work for the BOL is carried out by the top management of the Law Department, including the estimated time of the Deputies and County


Attorney in the calculation would increase the non-billable hours for the BOL from 5% to approximately 19% of the total number of non-billable revenue.


For the fiscal year that will end December 31, 2015 the Law Department is projecting to provide approximately 82,950 hours of billable client services, yielding over \$12,442,500 from both revenue streams: Inter- Departmental and Departmental. If the number of hours for non-billable services is included, then the number of hours for the year increases to approximately 100,130 hours

Moreover in 2016, in addition to the usual workload, including that reflected in the highlights of law department accomplishments for 2015 which follow herein, we anticipate performing extensive legal work related to: implementation of the terms of the ADC stipulation including legislation and potential litigation as necessary and appropriate.

The projected Inter-Departmental breakdown of revenue for 2015 is charted below.







Risk Management's departmental revenue is derived from reimbursement from the 6-N fund for expenses associated with the investigation and claims management of general, automobile, public officials and medical malpractice liability claims. Staff time is allocable to this function in addition to other indirect costs.

Appeals, Opinions and Legislation Bureau

Appeals

The Appeals, Opinions and Legislation Bureau defends and prosecutes all civil appellate litigation on behalf of the county, its departments, boards, commissions, agencies, officers and employees, acting their official capacities. The appeals are heard in state and federal courts. In addition to numerous Family Court Appeals prosecuted by the Bureau, below are representative examples of recent Appeals.

Name of Accomplishment: Westchester v. U.S. Dep't of Housing & Urban Dev.

When Initiated: 2013 Current Status: Completed

<u>Description</u>: The County initiated a federal lawsuit to seek recovery of millions of dollars in community planning development funds that the U.S. Dep't of Housing & Urban Development had withheld. The district court dismissed the action for lack of subject matter jurisdiction, and the County appealed to the Second Circuit Court of Appeals. The matter was fully briefed, oral argument has been conducted, and the Second Circuit reversed the district court's order.

Name of Accomplishment: Cetina v. Westchester

When Initiated: 2012 Current Status: Completed

<u>Description</u>: Mr. Cetina, a Lieutenant with the Department of Public Safety, commenced this federal action seeking millions of dollars damages. The district court dismissed the action in its entirety, and Mr. Cetina appealed to the Second Circuit Court of Appeals. The matter was fully briefed, oral argument was conducted, and the dismissal was affirmed on September 30, 2014. Mr. Cetina then filed a petition for a writ of certiorari with the United State Supreme Court. The County successfully defended that petition.

Name of Accomplishment: Hoffman Investors Corp. v. Ruderman, et al.

When Initiated: 2012 Current Status: Decided

<u>Description</u>: Petitioners in this action were found by the Westchester County Human Rights Commission to have violated the Westchester County Fair Housing Law by discriminating against minority applicants. Petitioners commenced an Article 78 proceeding, challenging both the evidentiary basis of the decision and whether the Westchester County Board of Legislators had the authority to create the Human Rights Commission. The Supreme Court transferred the case to the Appellate Division. The Appellate Division upheld the determination of the Human Rights Commission, and denied the Article 78 proceeding. Petitioners have subsequently paid approximately \$38,000 to Westchester Residential Opportunities (~\$24,000) and the HRC (~14,000) for the underlying penalties imposed by the Commission, with interest.

Name of Accomplishment: McLaughlin v. Hankin, et al.

When Initiated: 2012 Current Status: Decided

<u>Description</u>: Petitioner, a former counselor at the Westchester Community College, initiated an Article 78 proceeding challenging her denial of tenure and subsequent termination. Following a hearing, the Supreme Court found that WCC violated the applicable collective bargaining agreement and that Petitioner was entitled to reinstatement and tenure. WCC appealed. The Appellate Division reversed and dismissed the underlying petition, finding that Petitioner did not adequately plead her case.

Name of Accomplishment: Westchester County Correction Superior Officers Ass'n

v. County

When Initiated: 2010 Current Status: Decided

<u>Description</u>: The Westchester County Correction Superior Officers Association brought this action seeking Workers' Compensation equivalent benefits for correction superior officers claiming permanent partial disability resulting from employment with the County. A motion for summary judgment was granted in favor of the County, finding that SOA has failed to state a cause of action. SOA has appealed from this decision, and the County cross-appealed from a denial of its motion to dismiss in the action. The Appellate Division affirmed the granting of summary judgment in favor of the County.

Opinions

The Bureau provides legal advisory opinions to county officers and officials. The County Attorney also decides appeals under the Freedom of Information Law Appeals from decisions of other county departments and agencies, regarding access to their records.

Legislation

Pursuant to the Laws of Westchester County, the County Board of Legislators has the power to act by Local Law, Act or Resolution. In addition, the County Board of Legislators may request that the New York State Legislature pass state legislation granting the county certain specific powers that it would not otherwise possess under New York State law.

The Appeals Bureau is responsible for reviewing and drafting certain pieces of local and New York State legislation for the County Executive and the County Board of Legislators as may be appropriate under the circumstances. Each request for legislation is initially reviewed for legality, including such issues as whether such legislation would be preempted by state or federal law, whether such legislation requires a mandatory or permissive referendum prior to becoming effective and whether such legislation is subject to SEQRA review. Moreover, assuming legislation is legally appropriate, a committee report including the intent of the law or act, a transmittal letter and a resolution for a public hearing, accompanying all local laws, is also prepared.

Prevention & Training Programs:

Ongoing Initiative Workplace Violence Prevention Program

<u>Description</u>: In a joint effort with Human Resources, Public Safety and Public Works, the Law Department participates in the ongoing development, implementation and monitoring of the County's Workplace Violence Prevention Program. Through the Workplace Violence Prevention Committee, reports and occurrences of workplace violence are monitored and reviewed, and appropriate recommendations made therefrom, in order to track and reduce the occurrence of workplace violence in the County.

Conducting Freedom of Information Law ("FOIL") Training for County Employees

When Initiated: 2004

Current Status: Presentations available upon e-mail request.

<u>Dollars Saved:</u> The dollars that have been saved as a result of this ongoing initiative cannot be calculated by a special dollar figure. Nevertheless, the absence of, or decrease in, the amount of legal opinions and/or lawsuits which may result from errors in responding to requests for release of information certainly results in a cost savings to the County.

<u>Description</u>: This presentation, to be provided by members of the Law Department, will contain information, including the most recent updates to the Freedom on Information Law and general guidance to County officers and employees who are designated to be the FOIL officers of their particular County department, in accordance with the New York State Public Officers Law and the Laws of Westchester County. The objective of these seminars is to educate County employees on various FOIL issues and procedures.

<u>Name of Accomplishment</u>: Development of Affordable Units that Affirmatively Further Fair Housing in accordance with County Policy and the Housing Settlement.

When Initiated: 1990s Current Status: Ongoing

FEDERAL COURT CASES:

Ackridge v. Westchester County

When Initiated: 2015

Current Status: Case dismissed
Dollars Saved: Difficult to determine

Description: Plaintiff alleged that he was being illegally held at the Westchester County Jail by the County because he was denied a fair parole hearing process. Such process is under the purview of NYS Dept. of Correction & Community Supervision. The County successfully defeated Plaintiff's Writ of Habeas Corpus and his motion to renew and/or reargue his position.

Bell v. Correction Officers Diaz, Holmes, Olimpio and Allen

When Initiated: 2012

Current Status: Case settled for \$50,000.

Dollars Saved: Difficult to determine. Plaintiff requested punitive damages.

Description: Plaintiff brought this civil rights action against Defendants/ County Correction Officers and members of the Department's Emergency Response Team, and alleged that they used excessive force when they were removing him from his cell. Due to the inherent risks of litigation, the potential liability for payment of plaintiff's legal fees, the mental status of the inmate, the matter was settled prior to trial.

Berger v. Astorino, et al.

When Initiated: 2014

Current Status: Case dismissed.

Dollars Saved: Difficult to determine. Plaintiff sought reinstatement to his former position as Executive Director of Solid Waste Licensing, compensatory and punitive damages, and counsel fees. Description: Plaintiff, the former County Executive Director of Solid Waste Licensing, alleged that he was fired because of his political affiliation and that his termination was in violation of his rights to free speech and association. The Court granted the County's motion to dismiss the complaint.

Caldarola v. Westchester County

When Initiated: 2015

Current Status: Case dismissed.

Dollars Saved: Difficult to determine.

Description: Plaintiff brought various employment discrimination claims largely based upon his allegation that the County was withholding Workers' Compensation payments from him due to his age, race, and disability. The Court granted the County's motion to dismiss the complaint.

Cetina v. Westchester County

When Initiated: 2012

Current Status: Case dismissed.

Dollars Saved: Difficult to determine. Plaintiff sought \$3,000,000 in punitive damages, \$600,000 in compensatory damages for lost wages, an undisclosed amount for direct and compensatory damages for medical, psychological injury and pain and suffering, and attorneys' fees.

Description: Plaintiff commenced this federal action claiming employment discrimination in the Department's alleged failure to promote him to Captain. In December 2013, the District Court granted the County's pre-answer motion to dismiss the Complaint. Plaintiff appealed. On September 30, 2014, the Second Circuit affirmed that decision. Mr. Cetina filed a petition for certiorari, which was successfully defended by the County.

Cirulli v. Astorino, et al.

When Initiated: 2014

Current Status: Case dismissed.

Dollars Saved: Difficult to determine. Plaintiff sought compensatory and punitive damages and

attorney's fees.

Description: Plaintiff sued the County Executive and others relating to the rejection of his appointment to the Westchester Medical Center's Board of Trustees. The County successfully obtained dismissal of the action as against all County defendants.

Deanda v. Hicks, Thomas, Pavone, Caporale

When Initiated: 2013

Current Status: Case dismissed.

Dollars Saved: Difficult to determine. Plaintiff requested punitive damages.

Description: Plaintiff brought this action against Defendants/County Police Officers, wherein she alleged violations of the Fourth, Fifth, Sixth and Fourteenth Amendments to the United States Constitution, among other things, and New York State common law, as a result of her arrest for possession of oxycodone pills without a prescription in an unlabeled container. The Court granted the County's Motion for Summary Judgment and dismissed the case.

Gomez v. County, et al.

When Initiated: 2012

Current Status: Case dismissed, appeal pending.

Dollars Saved: Difficult to determine.

Description: Plaintiffs alleged that the jail healthcare providers failed to provide adequate dental care and respond promptly to dental emergencies. The Court granted the County's motion to dismiss. An appeal is pending.

Hanner v. County of Westchester, et al.

When Initiated: 2014

Current Status: Case dismissed.

Dollars Saved: Difficult to determine. Plaintiff was seeking millions of dollars in compensatory and punitive damages.

Description: Plaintiff alleged that she was subjected to numerous constitutional violations while incarcerated at the Westchester County Jail. After the County defendants submitted a letter to the Court requesting a pre-motion conference to move to dismiss plaintiff's complaint on certain enumerated grounds, the court scheduled a conference and dates for plaintiff to submit an opposition letter to the County defendants' request. When plaintiff failed to appear and did not respond to the County's application, the court dismissed the case. Although plaintiff has repeatedly requested that the court reconsider its decision or that the decision be appealed, the district court judge has denied plaintiff's requests.

Independence Party v. Astorino, et al.

When Initiated: 2013

Current Status: Case dismissed. Dollars Saved: Difficult to determine.

Description: The Westchester County Independence Party, and several individual members thereof, sued the County Executive and approximately 90 other individuals and entities, including the Board of Elections, claiming that the defendants engaged in racketeering activity and violated plaintiffs' civil rights. Following multiple amendments, the District Court granted the defendants' motions and dismissed the action in its entirety.

Kern v. Westchester County Community College, et al.

When Initiated: 2014

Current Status: Case settled for \$40,000.

Dollars Saved: Difficult to determine. Plaintiff demanded lost past and future wages, benefits, and compensation, punitive damages, and attorneys' fees.

Description: Plaintiff, a former employee of Westchester Community College, alleged that she was subject to discrimination and retaliation as a result of her medical condition and race. According to Plaintiff, the alleged discriminatory and retaliatory conduct taken by County employees forced her to retire early, caused her humiliation, embarrassment, as well as mental and emotional injuries, and resulted in loss of wages, benefits, and promotional opportunities. Due to the inherent risks of litigation, the potential liability for payment of plaintiff's legal fees, the matter was settled. The County paid plaintiff \$40,000 in exchange for a discontinuance of the action and a release from liability.

Membreno v. Westchester County, Sgt. Holmes and C.O. Torres

When Initiated: 2012

Current Status: Case settled for \$10,000.

Dollars Saved: Difficult to determine. Plaintiff requested punitive damages.

Description: Plaintiff alleged that excessive force was used against him while he was in court, that he was denied the right to file a grievance about the incident, and that the County had a pattern and policy of excessive force committed against inmates at the jail. Due to the inherent risks of litigation, the potential liability for payment of plaintiff's legal fees, and to avoid further expenses of litigation, the matter was settled by payment of \$10,000.

Rennalls v. Alfredo, et al.

When Initiated:

Current Status: Case against County Defendants dismissed.

Difficult to determine. Plaintiff demanded \$ 2,775,000 from the County. Dollars Saved: Description: Plaintiff (former inmate) brought this action alleging that a County correction officer failed to protect him against an unprovoked attack by another inmate and that this failure was indicative of a systemic failure of County policy. In addition to the state and federal claims alleged against the

County and its employee, Plaintiff also made claims against Correct Care Solutions in connection with his medical care following the attack. The County made a motion to dismiss the complaint against the

County and its employee, and the Court granted the motion.

Rodriguez v. Westchester County, Correct Care Solutions, et al.

When Initiated: 2012

Current Status: Case settled for \$9,000. Dollars Saved: Difficult to determine.

Description: Plaintiff, a former inmate, alleged that she was denied medical care and suffered damages as a result of the negligence of Correct Care Solutions and its medical staff as well as County employees. Plaintiff alleged that her medical conditions were ignored and exacerbated by the use of latex gloves and the denial of an EpiPen. Due to the inherent risks of litigation, the potential liability for payment of plaintiff's legal fees, and to avoid further expenses of litigation, the matter was settled by payment of \$9,000.

Rodriguez v. Rivera, et al.

When Initiated: 2012

Current Status: Case settled for \$9,000. (\$4,000 to plaintiff and \$5,000 to pay for public/medical

assistance liens.

Dollars Saved: Difficult to determine.

Description: Plaintiff claimed that the Odyssey House, Inc., a New York City long term residential facility, was not a suitable facility for her inpatient substance abuse rehabilitation. She alleged that her complaints regarding her placement were ignored and that she developed COPD due to a black mold allergy which exacerbated her asthma during her stay. Due to the inherent risks of litigation, the potential liability for payment of plaintiff's legal fees, and to avoid further expenses of litigation, the matter was settled by payment of \$9,000, \$4,000 of which was paid to plaintiff and \$5,000 was allocated to pay public/medical assistance liens.

Sander v. Westchester County, et al.

When Initiated: 2014

Current Status: Case dismissed.

Dollars Saved: Difficult to determine.

Description: Plaintiff alleged claims of a purported illegal condemnation of her property located in Yonkers and false arrest. The County made a motion to dismiss this complaint, and the Court granted the motion.

Shaver v. Westchester County, et al.

When initiated: 2014

Current status: Case settled for \$24,000. Dollars saved: Difficult to determine.

Description: Plaintiff, a former inmate, claimed that County miscalculated his discharge date and incorrectly applied New York State Penal Law Section 70.30(2)(b). He alleged violations of his civil rights, including claims of false imprisonment, cruel and unusual punishment, unlawful seizure, lack of procedural due process, and state law claims for false imprisonment and negligence. During his incarceration, Plaintiff challenged the County's calculation in the State Supreme Court. His petition was denied; however, Second Department reversed the lower court. The Court of Appeals affirmed the Second Department's decision. Upon the County's motion, the District Court dismissed certain federal claims but denied the County's motion with respect to the federal claims of false imprisonment and procedural due process and the state claims of false imprisonment and negligence. Due to the inherent risks of litigation, the potential liability for payment of plaintiff's legal fees, and to avoid further expenses of litigation, the matter was settled by payment of \$24,000.

Sutton v. County of Westchester, et al.

When Initiated: 2013

Current Status: Case dismissed.

Dollars Saved: Difficult to determine.

Description: Plaintiff brought this federal civil rights action against the County of Westchester and three other non-County defendants alleging excessive force, false arrest and false imprisonment. The County filed a motion for summary judgment and the Court granted the motion, dismissing the action.

United States v. Westchester County

When Initiated: 2014

Current Status: Case settled.

Dollars Saved: Approximately \$89 million.

Description: The United States, on behalf of the Environmental Protection Agency, sued the County relating to the treatment of drinking water in Water District No. 1. The United States was seeking penalties against the County, under the Safe Drinking Water Act, in an amount of \$37,500 per day, for a period of approximately six years, for a total of nearly \$90 million. Following extensive discovery, the County negotiated a consent decree which provided for the payment of approximately \$1 million in penalties.

Vessa v. County of Westchester, et al.

When Initiated: 2012

Current Status: Case dismissed.

Dollars Saved: Difficult to determine.

Description: Plaintiff alleged that a search of his home was wrongfully obtained in violation of his civil rights. The Court granted the County's motion to dismiss. Plaintiff filed an appeal with the Second Circuit, which was successfully defended by the County.

STATE COURT CASES

40 Reynal Road Corp. v. County of Westchester and the City of White Plains

When Initiated: February 2015 Current Status: Case dismissed.

Dollars Saved: A substantial, but undetermined amount.

Description: Plaintiff brought this action seeking declaratory judgment, injunctive relief and for damages relating to an alleged failure by the County to maintain, or enforce maintenance of, a stone footbridge and a portion of the Western Branch of the Mamaroneck River. Plaintiff claimed that the lack of maintenance was creating a public hazard, damaging its land and its ability to develop it, and greatly diminishing its property value. The County moved to dismiss the complaint upon the grounds that the County did not have any duty to plaintiff or to maintain the footbridge or waterway in question based

upon the relevant County codes regarding stream control and water channel demarcations. The County's motion was granted.

Airport Mart v. County of Westchester

When Initiated: 2015

Current Status: Case dismissed. A notice of appeal has been filed by Petitioner.

Dollars Saved: Difficult to determine.

Description: Petitioner claimed that the County improperly awarded a contract to another vendor to operate at the Westchester County Airport and asserted breach of contract claims against the County. The County successfully obtained a full dismissal of the action.

Ansell v. County of Westchester

When Initiated: April 2015
Current Status: Case dismissed.
Dollars Saved: Difficult to determine.

Description: Petitioner claimed that the Westchester County Jail miscalculated his jail-time credit regarding the state sentence he is currently serving. The County's motion to dismiss was granted.

In re Ashford Avenue Bridge

When Initiated: 2015

Current Status: Matter withdrawn.
Dollars Saved: Not applicable

Description: This action was commenced in order to forcibly obtain certain easements, via eminent domain, that were required to repair the Ashford Avenue Bridge. Following the initiation of the proceeding, the County was able to secure the easements from the property owners, allowing the County to discontinue the action.

Matter of Dennis v. Westchester County Human Rights Commission

When Initiated: 2015

Current Status: Case dismissed.

Dollars saved: Difficult to determine.

Description: Petitioner challenged the dismissal of her discrimination complaint by the Westchester County Human Rights Commission (the "HRC"). The County moved to dismiss the proceeding on the grounds that: (i) Petitioner failed to comply with the service of process directives set forth in the Order to Show Cause; (ii) the HRC's determination was neither arbitrary nor capricious nor lacking a rational basis in the records; and (iii) failure to state a cause of action. The Court granted the County's motion to dismiss.

Eisemann v. County of Westchester, et al.

When Initiated: 2015

Current Status: Case dismissed against County defendants.

Dollars Saved: Difficult to determine. Plaintiff demanded \$108.897.22 ("rate" supposedly agreed

upon) or \$215,523.00 (the claimed "reasonable value" of services).

Description: Plaintiff brought this action seeking payment of legal fees pursuant to alleged contracts to represent the Westchester County Board of Legislators in litigation pertaining to changes of the Board of Acquisition and Contract's composition and the rate of daycare cost contributions. Plaintiff made claims

of breach of contract, account stated, unjust enrichment, promissory estoppel, quantum meruit, and mandamus. The County made an unopposed motion to dismiss the complaint against the County and its employees and the Court granted the motion.

Hodge v. County of Westchester

When Initiated: 2012

Current Status: Case dismissed on summary judgment

Dollars Saved: Plaintiff demanded \$1,000,000.

Description: Plaintiff, a former inmate, alleged that he was assaulted by another inmate while in the custody of the County Department of Corrections. Plaintiff alleges the County was negligent in its supervision of the inmates, and that it was liable for negligent hiring and training of its correction officers. Plaintiff also alleged that the County was liable for constitutional violations. After completion of discovery, the County moved for summary judgment. On March 4, 2015, the Court granted the County's motion and dismissed the matter.

Jones v. County of Westchester, et al.

When Initiated: 2012

Current Status: Case dismissed on summary judgment.

Dollars Saved: Difficult to determine. Plaintiff's settlement demand was \$150,000. Description: Plaintiff, a former inmate at the County Department of Corrections, was being transported from Rikers Island to Westchester County when the County van collided with a livery cab driver in Queens County. Plaintiff alleged that he was not provided the opportunity to use a safety restraint which contributed to his injuries in addition to the alleged negligent operation of the County van at the time of the accident. In July 2015, the Court granted the County's motion for summary judgment and dismissed the case against the County and the individual correction officers involved in the accident.

McKelvin v. NYS Office of Children and Family Services and Westchester County

When Initiated: 2014

Current status: Case dismissed as against the County

Dollars saved: Difficult to determine.

Description: Petitioner challenged a decision made by the NYS Office of Children and Family Services that upheld the County's finding of maltreatment. The County moved to dismiss the proceeding on the grounds that: (i) there was no statutory basis for the instant proceeding as against the County, as the County was not a proper or necessary party to the proceeding; and (ii) the petition did not allege a cause of action as against the County. The Court granted the County's motion to dismiss this matter and all claims against the County were dismissed.

Magnotta v. County of Westchester

When Initiated: 2012

Current Status: Case settled for \$60,000.

Dollars Saved: Difficult to determine. Plaintiff had demanded \$125,000.

Description: Plaintiff, an elderly woman, alleges that she was walking on the grounds of the Kensico Dam Plaza when she was caused to trip and fall over a raised brick paver abutting a concrete walkway near the restrooms. Plaintiff fractured her nose, sprained her left wrist and suffered minor tearing to her rotator cuff, left arm. Due to the inherent risks of litigation, and to avoid further expenses of litigation, the matter was settled by payment of \$60,000.

Motta v. County of Westchester, et al.

When Initiated: 2012

Current Status: Case dismissed.

Dollars Saved: Difficult to determine. Plaintiff was seeking millions of dollars in compensatory

punitive damages.

Description: Plaintiff alleged that, while he was participating in a 9/11 Tribute Ride with other motorcyclists traveling southbound on the NYS Thruway, the motorcycle he was operating was struck by a vehicle entering the NYS Thruway in Rockland County, causing him to sustain injuries, including the loss of his leg. Plaintiff claimed that his accident was caused by the negligence of the County Department of Public Safety in its failure to control traffic, including failing to close the entrance ramps to the NYS Thruway, failing to provide proper protection from other motor vehicles on the NYS Thruway and failing to properly escort the 9/11 tribute ride. The County moved for summary judgment to dismiss the case on the grounds that the Westchester County police officers who assisted with the 9/11 Tribute Ride neither caused, nor contributed to the happening of the accident involving plaintiff and that the NYS Thruway was not under the control, nor jurisdiction of the County and its Department of Public Safety. The County also moved to dismiss upon the grounds that in terms of any policing decisions that were made during the 9/11 Tribute Ride, the County had no special relation with plaintiff and therefore did not owe plaintiff a duty to prevent the within traffic accident from happening. The court granted the County's motion and dismissed the action against the County.

Pichardo v. County of Westchester and GPS Industries

When Initiated: 2013

Current Status: Case settled for \$70,000.

Dollars Saved: Difficult to determine. Plaintiff had demanded \$325,000.

Description: Plaintiff was an independent contractor hired by GPS Industries to work on the GPS system at Saxon Woods Golf Course. Plaintiff alleged that he used a ladder provided to him by County personnel to access GPS antennae on the roof of the clubhouse when the ladder slipped out from under him. Plaintiff claims that as a result, he fell onto the flat portion of the roof and sustained multiple injuries, including back disk herniation, a tear to his left ACL, shoulder injury, and nerve damage. Plaintiff sued the County under the strict provisions of the NYS Labor Laws. Through the process of formal mediation, the plaintiff settled his claim against the County for \$70,000.

Pinker v. Westchester County and POMCO, Inc.

When Initiated: 2013

Current Status: Case settled for \$223,428.

Dollars Saved: \$373,613.10 was demanded in Complaint plus costs of litigation.

Description: The Complaint alleged that Plaintiff, an out of network treatment provider, was wrongfully denied payment for certain medical treatments/services provided to Westchester County employees pursuant to the Westchester County Health Care Benefits Plan. During the course of discovery this case settled for \$223,428, with a full release from liability.

Rodriguez v. Board of Elections, et al.

When Initiated: 2015

Current Status: Case dismissed.

Dollars Saved: Difficult to determine.

Description: Petitioner sought an order pursuant to the New York State Election Law declaring null and void, every nomination for village office of the Village of Sleepy Hollow Democratic Party Caucus held on January 21, 2015. The County Board sought dismissal of the petition because petitioner failed to verify the petition. The Court agreed and the petition was dismissed.

Servelli v. County, et al.

When Initiated: 2007

Current Status: Defense verdict after jury trial.

Dollars saved: Difficult to determine. Plaintiff claimed to have suffered traumatic brain injury

with significant residual injuries.

Description: Plaintiff commenced this action against the owner and driver of a tractor trailer on the Central Westchester Parkway, the driver of an automobile who occupied the lane the tractor trailer tried to merge into, and the County for failing to post adequate signs to warn oversized vehicles. Plaintiff was operating a motorcycle at the time of his accident. When the tractor trailer got stuck under an overpass the plaintiff claimed he was faced with an emergency situation which caused him to crash into the back of one of the vehicle stuck on the roadway. The County tried the case to verdict and won.

Simmons v. Westchester County Department of Social Services

When Initiated: 2015

Current Status: All three proceedings dismissed.

Dollars Saved: Difficult to determine.

Description: Petitioner commenced three separate proceedings as against the County, challenging three separate decisions rendered by the New York State Office of Temporary and Disability Assistance regarding public assistance benefits. The County moved to dismiss each of the three the proceedings because: (i) there was no statutory basis for the proceedings as against the County, and thus, Petitioner failed to state claims against the County; (ii) the County was not a necessary or proper party to the proceedings; and (iii) Petitioner failed to name a necessary party to the proceedings, namely New York State. The Court granted all three of the County's dismissal motions.

Streng v. Board of Elections, et al.

When Initiated: 2015

Current Status: Case dismissed. Dollars Saved: Difficult to determine.

Description: Petitioner sought an order pursuant to New York State Election Law directing the County Board of Elections to conduct a second drawing to determine the ballot position of Petitioner and Respondent Brandon R. Sall, for nomination of the Democratic Party for the position of Judge of the Westchester County Surrogate's Court, in the Primary Election to be held on September 10, 2015; and restraining and enjoining the Board from printing and placing the names of Petitioner and Respondent Sall upon the official ballot of the Primary Election in accordance with the drawing held on August 6, 2015. The Board challenged the petition. The Court agreed with the Board and held that the Board complied with the notice provisions of Election Law § 7-116(3). The petition was dismissed.

Westerly Realty Corp. vs. County of Westchester, et al.

When Initiated: 2011

Current Status: Case dismissed.

Dollars Saved: Difficult to determine. Plaintiff claimed damages of approximately \$90,000. Description: Plaintiff claimed that it sustained property damage to its business premises when untreated wastewater entered his facility through the floor drains and plumbing fixtures. Plaintiff claimed that the County negligently designed, maintained, and allowed excessive use of its sanitary trunk line servicing the premises. After the completion of discovery, the County moved for summary judgment. The Court granted the County's motion and dismissed the case.

Williams v. County of Westchester, et al.

When initiated: 2011

Current status: Case settled for \$50,000.

Dollars Saved: Difficult to determine. Plaintiff claimed traumatic brain injury and extensive in-

patient rehabilitation.

Description: Plaintiff crossed a County roadway to enter school grounds and was hit by a truck. The case against school district and the town were dismissed by the Court. The truck company settled. The claim against the County was that based on allegations of failure to conduct an adequate traffic study and address the needs of children who may walk to school. Due to the inherent risks of litigation, and to avoid further expenses of litigation, the matter was settled by payment of \$50,000.

Wireless Edge Consultants, LLC v. County of Westchester

When Initiated: 2014

Current Status: Case dismissed.

Dollars Saved: Difficult to determine.

Description: Petitioner sought the annulment of the award of a contract to Pinnacle Towers LLC for the use and operation of an antenna tower and its appurtenant structures located at the Westchester Community College. Petitioner claimed that the County violated the competitive bidding requirements and acted arbitrarily and capriciously when it awarded the license to Pinnacle Towers LLC. The County moved to dismiss the petition because (a) petitioner lacked standing; (b) petitioner failed to name a necessary party; (c) documentary evidence conclusively established a defense to the allegations as a matter of law; and (d) the petition failed to state a claim. The Court granted the County's motion and dismissed the petition.

Zeigler v. Westchester County Department of Public Safety, et al.

When Initiated: 2014

Current Status: Case dismissed. Dollars Saved: Difficult to determine.

Description: Petitioner commenced this Petition under Article 4 of the CPLR seeking an order annulling Westchester County Taxi and Limousine' Commission's ("WCTLC") determination whereby Petitioners were fined, after a hearing, for violating certain WCTLC Rules and Regulations upon the grounds that Respondent, WCTLC, lacks the statutory authority to regulate for-hire vehicles, drivers, and base stations that do not provide transportation within the County of Westchester.

LOCAL COURT CASES

In the Matter of 450 Saw Mill River Road, Ardsley, NY, Town of Greenburgh

When Initiated: 2015

Current Status: Summons dismissed.

Dollars Saved: Difficult to determine.

Description: The Town of Greenburgh issued a Summons and Appearance Ticket to the County in connection with its elevator at 450 Saw Mill River Road, Ardsley, claiming that the County had to comply with town laws. The Town withdrew the summons.

ARBITRATIONS

COBA ex rel Becvar v Cheverko, et al.

When Initiated: 2015

Current Status: Case dismissed.

Dollars saved: Difficult to determine.

Description: Petitioner sought vacatur of a County Department of Correction medical arbitration award. The County challenged the petition, arguing that (i) the challenged language was part of the arbitrator's path of analysis and therefore beyond judicial scrutiny; (ii) the collective bargaining agreement did not preclude the arbitrator from giving an opinion; and (iii) the petitioner failed to state a cause of action. The Court granted the County's motion to dismiss.

State Division of Human Rights ("SDHR")/Equal Employment Opportunity Commission ("EEOC")/ US Department of Education Office of Civil Rights ("OCR") Matters:

C.H. v. Westchester County District Attorney's Office

When Initiated: 2015

Current Status: Case dismissed. Dollars Saved: Difficult to determine.

Description: Complainant alleged unlawful discriminatory practice in violation of Title VII of the Civil Rights Act of 1964, as amended, and claimed that he was discriminated against on the basis of his gender and race in connection with the termination of his probationary appointment. Complainant also alleged that his probationary period was terminated in bad faith. The County submitted its position statement. Upon review of the statement and investigation, the SDHR dismissed the complaint.

C.L. vs. Westchester Community College

When Initiated: 2014

Current Status: The charges relating to disability harassment were dismissed and the charges

concerning failure to provide reasonable accommodations were resolved by agreement.

Dollars Saved: Difficult to determine.

Description: Complainant alleged that a WCC professor denied her the use of a calculator on exams and that others refused to provide her with extra time to complete exams, resulting in failing grades in three classes. She also claimed that derogatory comments concerning her disability were made in the presence of other students, which rose to the level of disability harassment. Upon submissions by the County, the OCR issued a determination that insufficient evidence existed to establish disability harassment. The College entered into a Resolution Agreement regarding the claims of failure to provide

accommodations, whereby the College issued a withdrawal from the failing classes and allowed the student to retake the classes as an audit student.

K.M. v. County of Westchester

When Initiated: 2013

Current Status: Case dismissed. Dollars Saved: Difficult to determine.

Description: Complainant alleged unlawful discriminatory practices in violation of the Age Discrimination in Employment Act of 1967 and claimed that she was discriminated against on the basis of her gender and age in connection with the abolition of her position. Complainant also alleged that the abolition of her position was retaliatory. Upon submission of the County's position statement, and its investigation, the complaint was dismissed.

M.W. v. Westchester County Department of Social Services (Notice of Claim and EEOC Complaint)

When Initiated: 2014

Current status: Case settled by agreement to reinstate Complainant/claimant's probationary employment.

Dollars Saved: Difficult to determine.

Description: Complainant/claimant claimed that her probationary employment at the County Department of Social Services was terminated in violation of the ADA and that she was discriminated against on the basis of her religion and in violation of Worker's Compensation law. Case settled by agreement to reinstate Complainant/claimant's probationary employment.

S.P. v. Westchester County Department of Social Services

Description: Complainant commenced two separate matters with the EEOC, alleging discrimination by reason of race, ethnic background and genetic information. These matters were consolidated and successfully resolved by way of a conciliation agreement wherein the Department of Social Services agreed to pay a \$2,000 settlement and to transfer the Complainant to a different work site.
