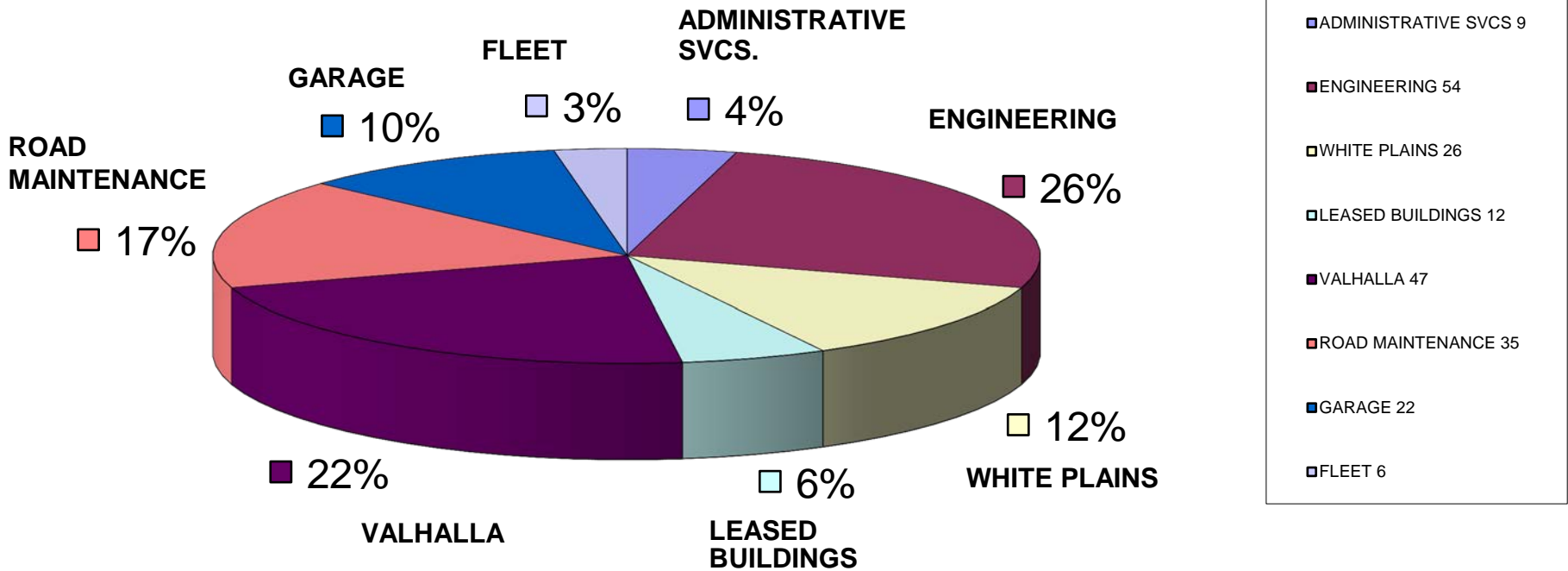

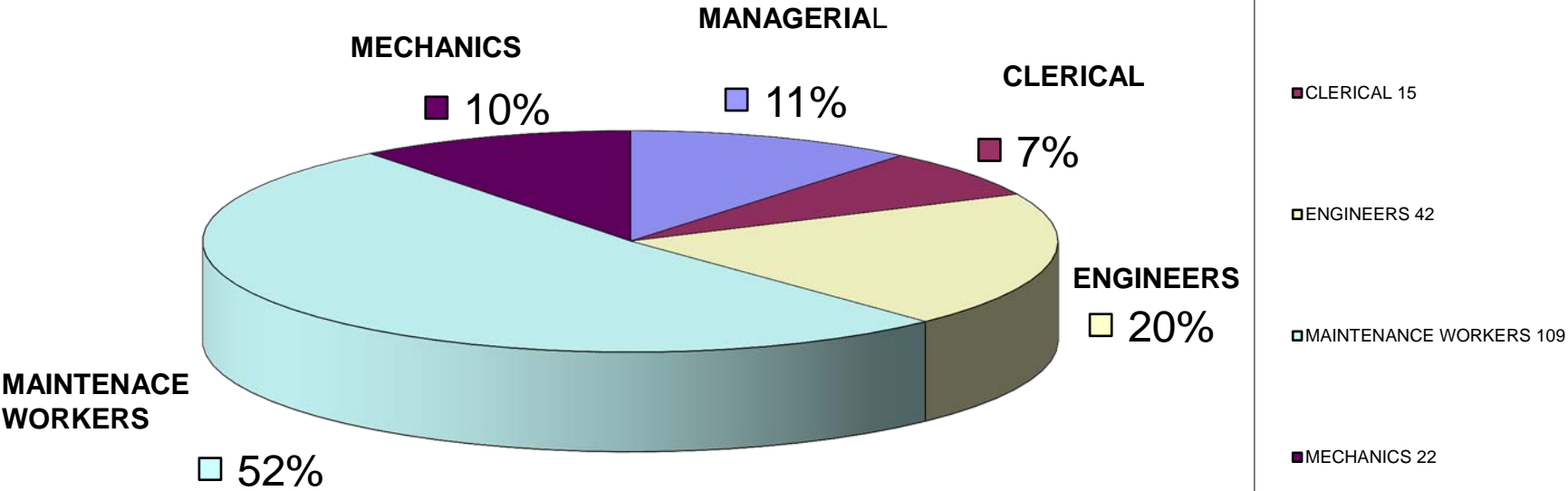

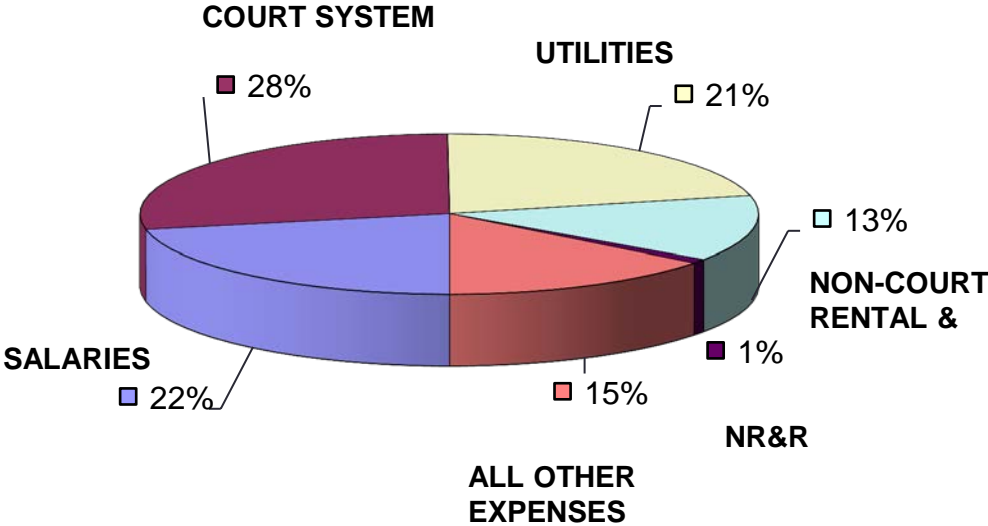
2016 DPW POSITIONS BY DIVISION



2016 DPW POSITIONS BY CATEGORY



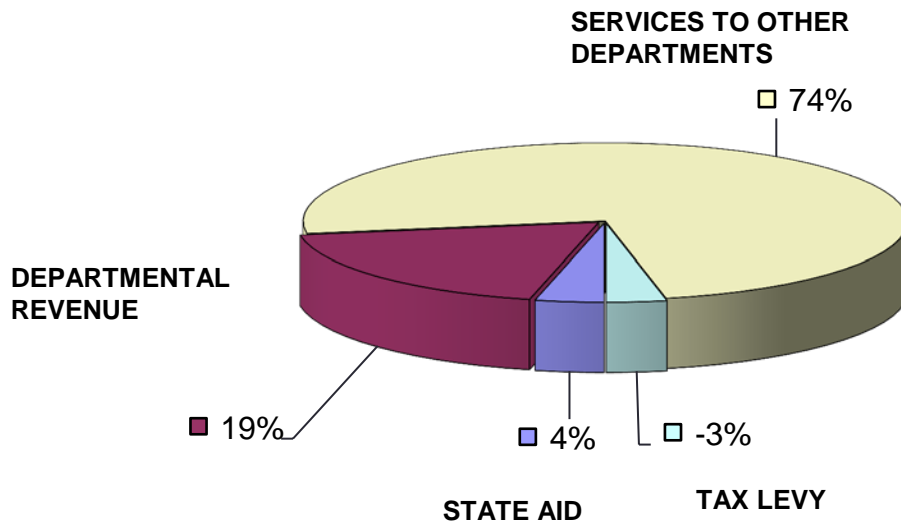
2016 DPW GROSS EXPENSE BY MAJOR COST CENTER

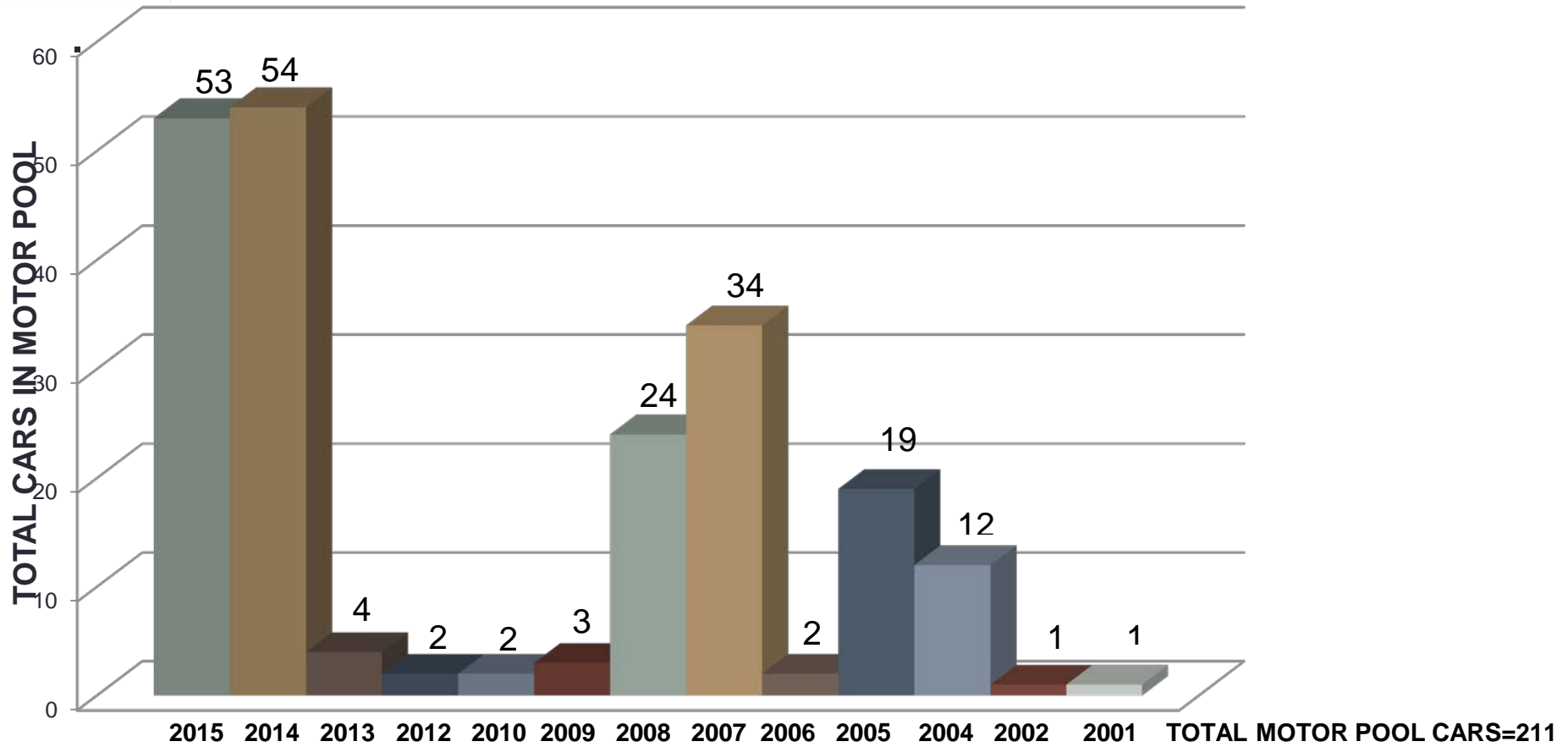

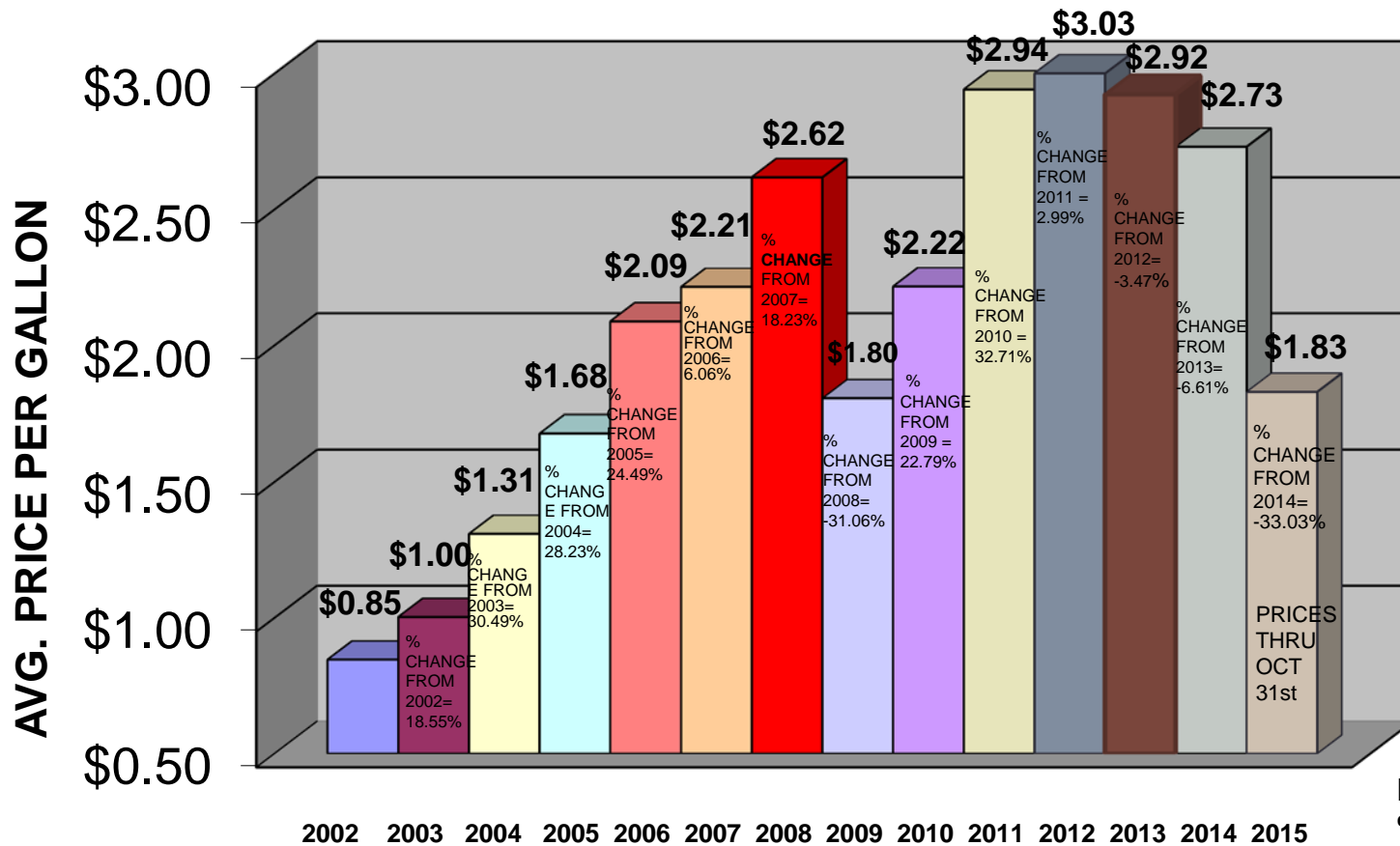

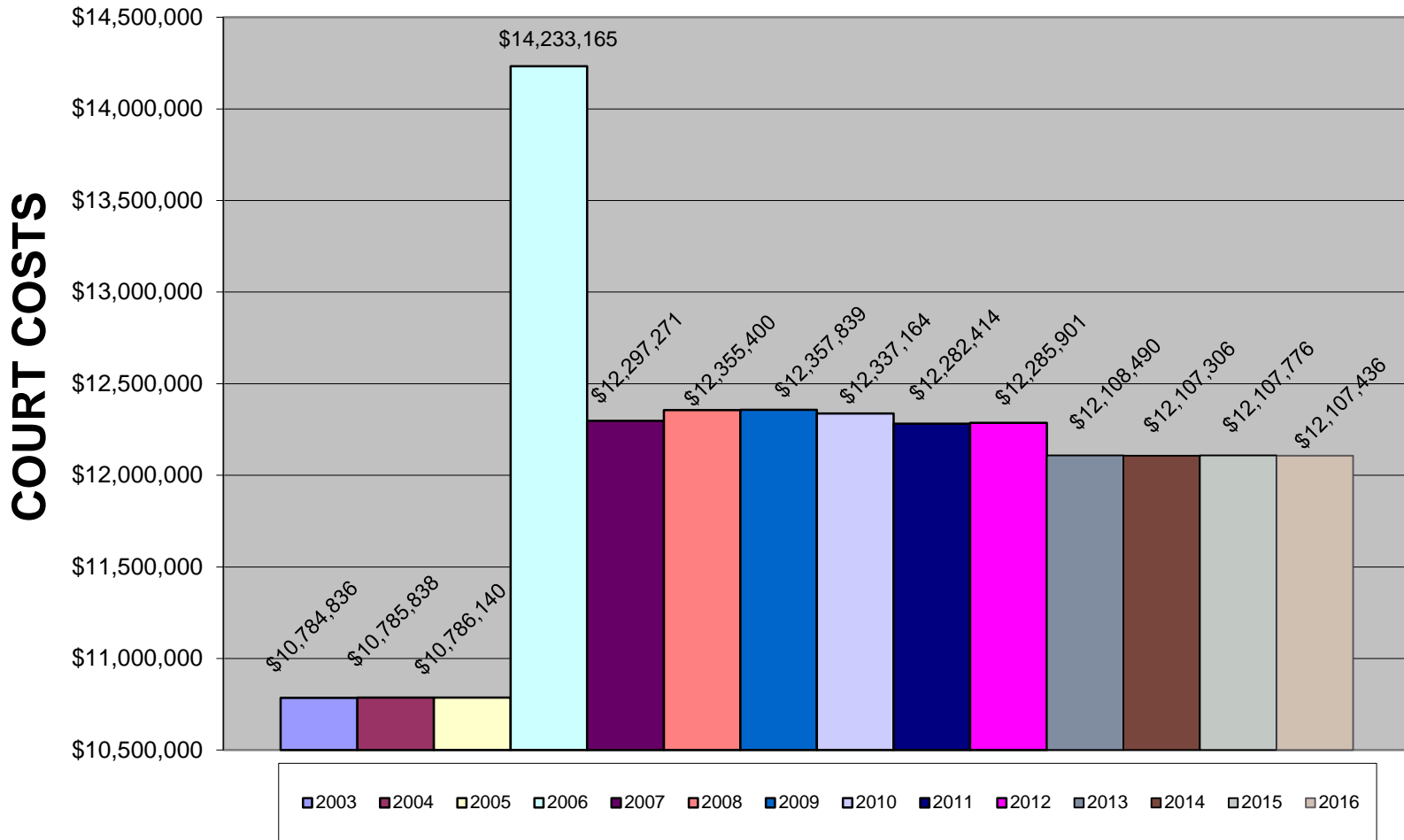
2002 – 2015 AVERAGE GAS PRICES



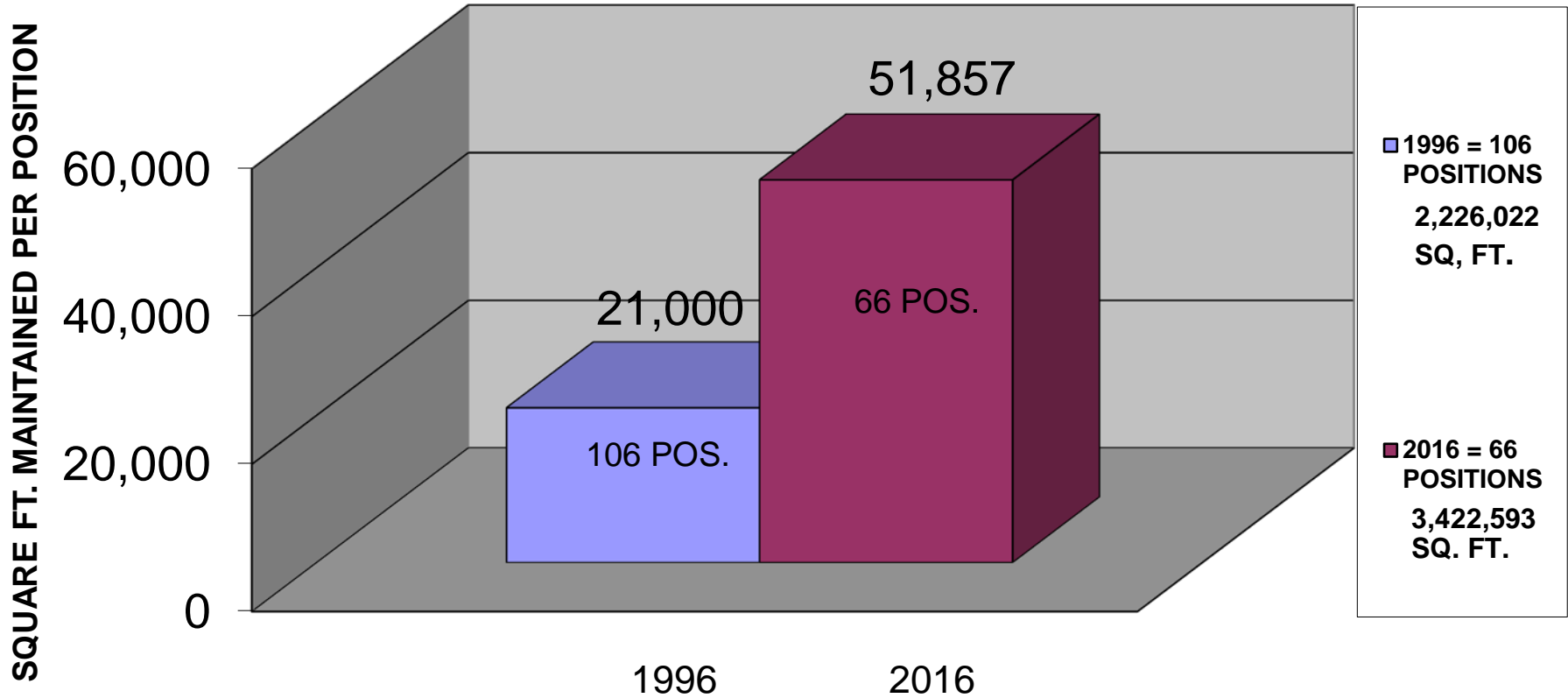

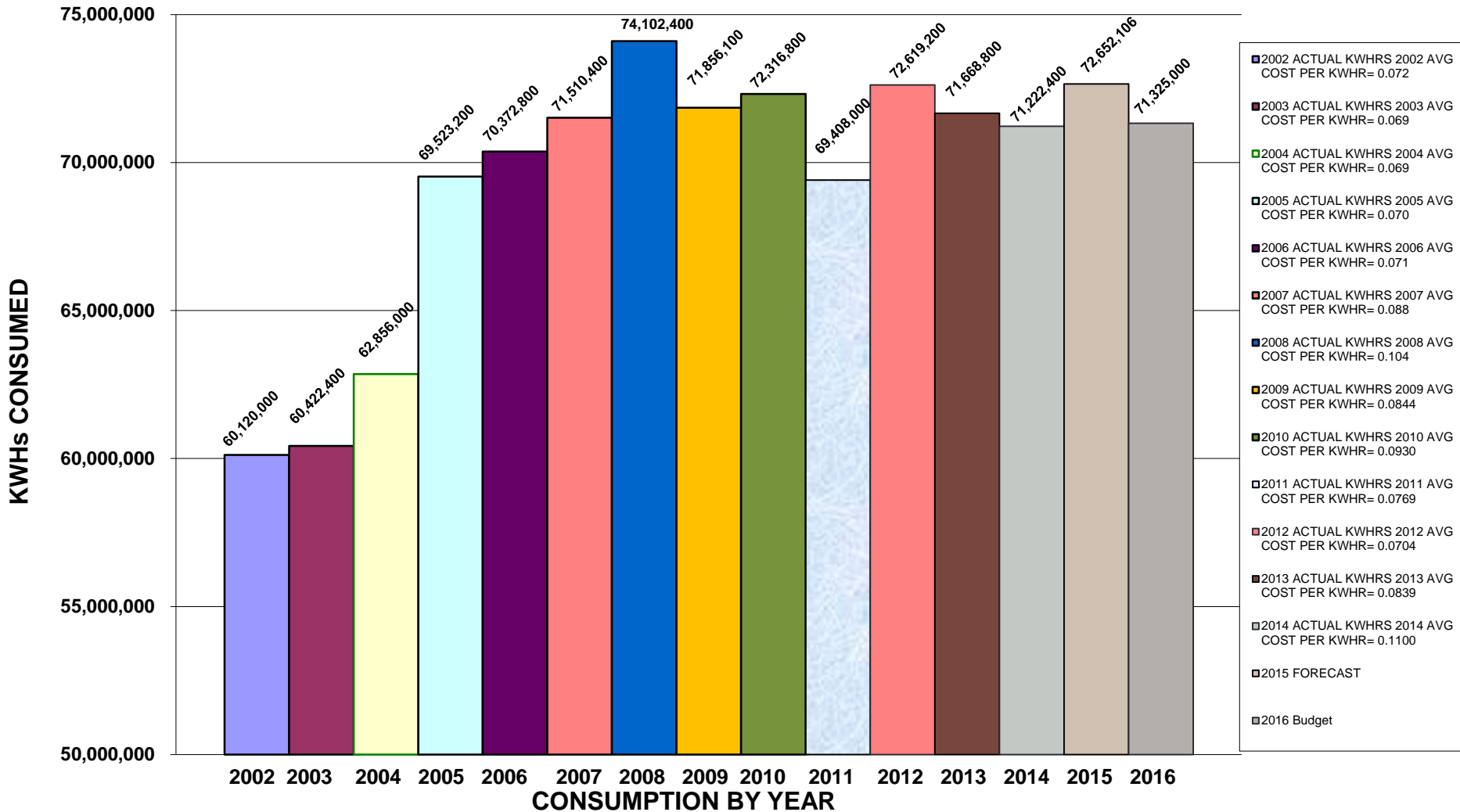
1996 – 2016 SQ FT MAINTAINED PER MAINTENANCE FTE FOR WHITE PLAINS & VALHALLA

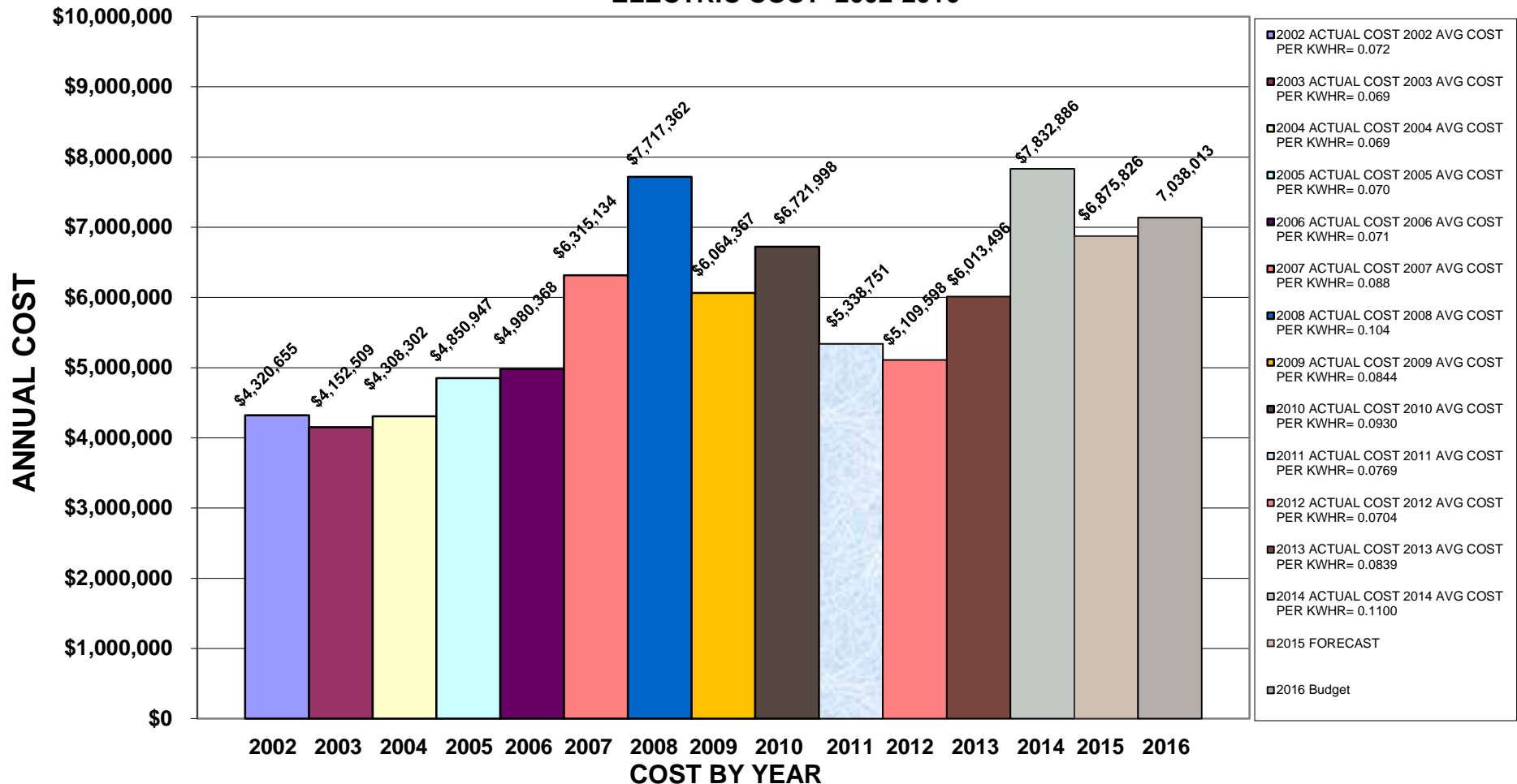
Valhalla Campus Annual Electric Consumption – KWHs

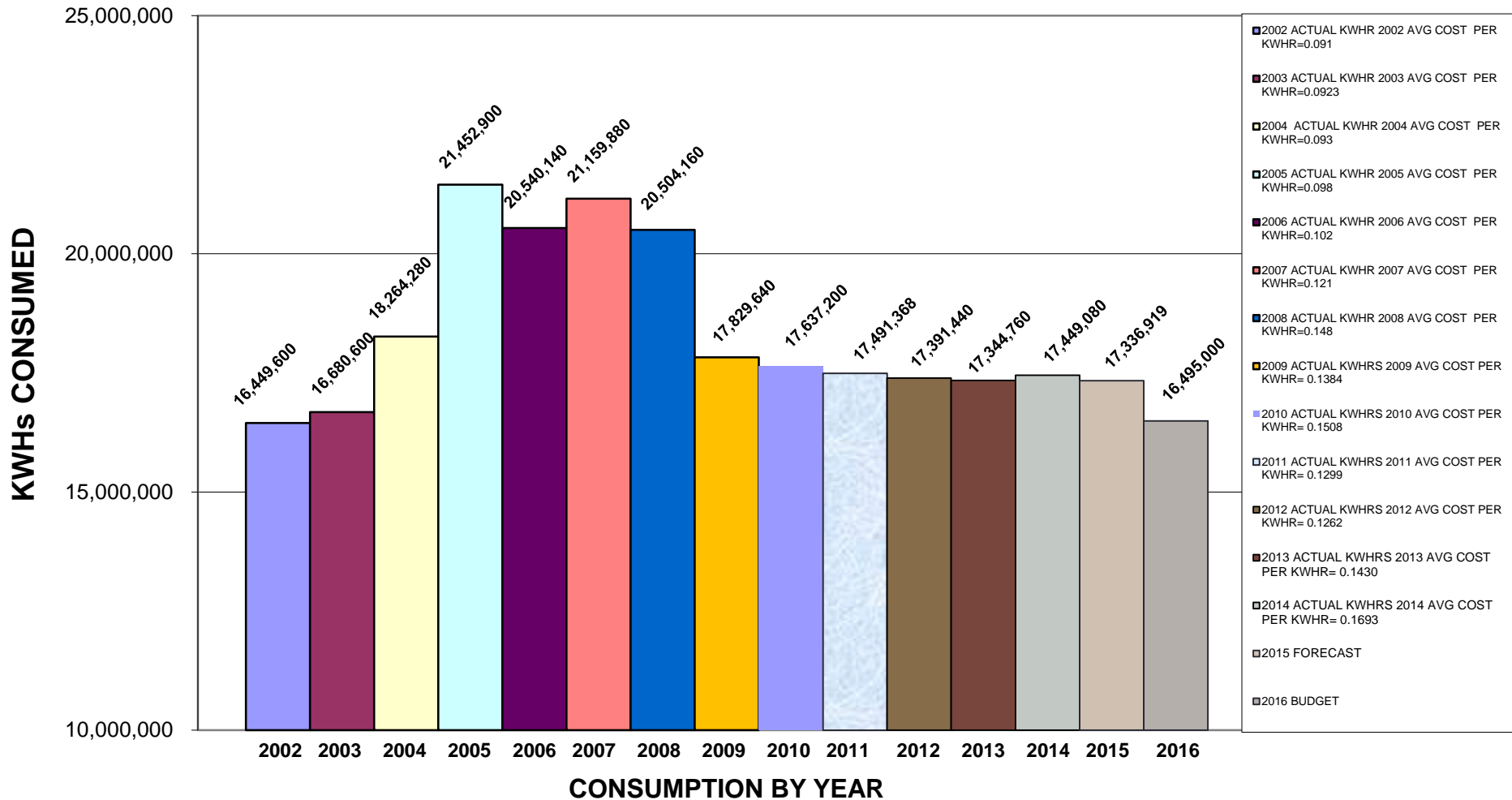


WHITE PLAINS COMPLEX ANNUAL ELECTRIC CONSUMPTION- KWHs

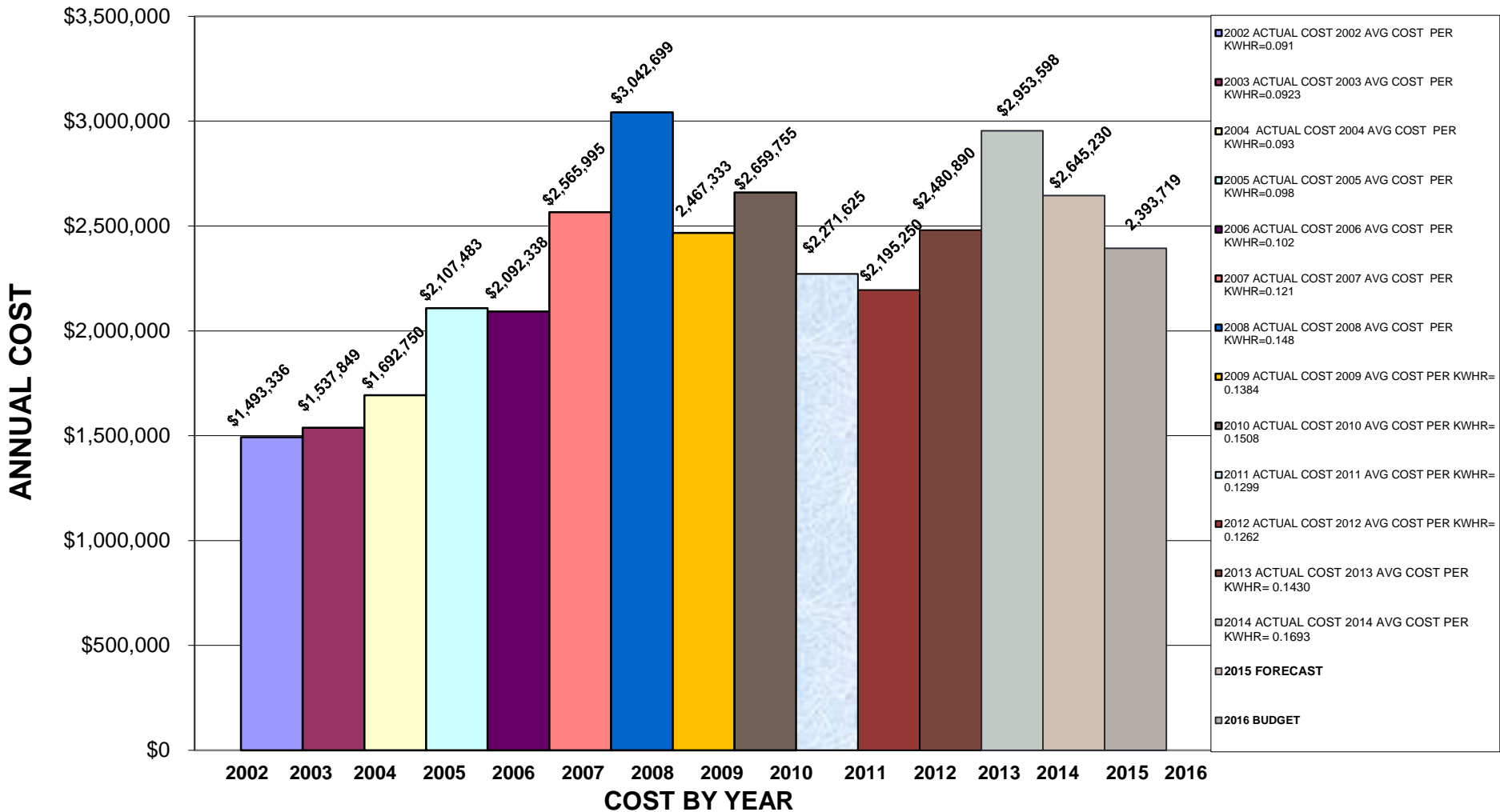
