HAS BEEN FORTUNATE TO HAVE MEN, WOMEN AND ORGANIZATIONS WHO GIVE OF THEIR TIME AND TALENT FOR THE BETTERMENT OF THE COMMUNITY, AND

WHEREAS, ON MARCH 1, 2010 WE CELEBRATE WOMEN'S HISTORY MONTH AND RECOGNIZE THE COURAGE, FORESIGHT AND RESOLVE OF WOMEN WHO HAVE STRENGTHENED OUR DEMOCRACY. WESTCHESTER COUNTY HAS BEEN TRANSFORMED BY STRONG WOMEN WHOSE CONTRIBUTIONS HAVE SHAPED OUR HISTORY AND CONTINUE THEIR LEGACY OF LEADERSHIP, AND

WHEREAS, AS WE OBSERVE AND CELEBRATE WOMEN'S HISTORY MONTH, A SPECIAL ORGANIZATION THAT HAS HELPED TO ADDRESS THE NEEDS OF WOMEN AND FAMILIES THROUGHOUT WESTCHESTER COUNTY AND IS DESERVING OF SPECIAL ACKNOWLEDGEMENT AND APPRECIATION FOR ALL IT'S HARD WORK IS THE WESTCHESTER COUNTY OFFICE FOR WOMEN, AND

WHEREAS, THE OFFICE FOR WOMEN, UNDER THE LEADERSHIP OF CAMILLE FAILLA MURPHY SINCE ITS INCEPTION, OFFERS INFORMATION AND REFERRAL FOR A WIDE RANGE OF PROBLEMS FACING WOMEN IN THE COUNTY INCLUDING FAMILY VIOLENCE, DISCRIMINATION IN THE WORKPLACE AND HOUSING, SEXUAL ASSAULT, POVERTY AND A LACK OF CHILDCARE. THEY OFFER A WIDE VARIETY OF EDUCATIONAL AND TRAINING PROGRAMS. OFFICIALLY OPENING ITS DOORS IN AUGUST 1980, THE WESTCHESTER COUNTY OFFICE FOR WOMEN BEGAN A NEW ERA FOR WOMEN IN WESTCHESTER AS THEY NOW HAD A CENTRALIZED COMMUNITY-BASED RESOURCE IN COUNTY GOVERNMENT WHICH WAS MANDATED TO ADDRESS THE NEEDS OF WOMEN AND THEIR FAMILIES, AND

WHEREAS, THE OFFICE FOR WOMEN COORDINATES A NETWORK OF AGENCIES OFFERING EMPLOYMENT ASSISTANCE AND TRAINING IN ADDITION TO PUBLIC EDUCATION AND RESEARCH, PUBLIC POLICY AND ADVOCACY AND MOST RECENTLY HISPANIC OUTREACH, AND

WHEREAS, WESTCHESTER COUNTY WAS THE FIRST COUNTY IN NEW YORK STATE TO ESTABLISH AN OFFICE FOR WOMEN AND IT HAS SERVED AS A MODEL FOR SIMILAR AGENCIES IN THREE OTHER COUNTIES IN NEW YORK. THE OFFICE FOR WOMEN IS A COMMISSION ON THE STATUS OF WOMEN AND A MEMBER OF THE NATIONAL ASSOCIATION OF COMMISSIONS ON WOMEN, AND

WHEREAS, ACCOMPLISHMENTS SUCH AS THOSE OF THE WESTCHESTER COUNTY OFFICE FOR WOMEN SHOULD BE PROPERLY RECOGNIZED AND ACCLAIMED, NOW, THEREFORE. BE IT

RESOLVED, THAT MARCH 1, 2010 BE PROCLAIMED "OFFICE FOR WOMEN DAY" IN WESTCHESTER COUNTY, AND BE IT FURTHER

RESOLVED, THAT THE MEMBERS OF THE WESTCHESTER COUNTY BOARD OF LEGISLATORS JOIN WITH THEIR COLLEAGUES, LEGISLATOR JUDY MYERS, LEGISLATOR BERNICE SPRECKMAN AND LEGISLATOR ALFREDA WILLIAMS, IN PAYING TRIBUTE TO THE WESTCHESTER COUNTY OFFICE FOR WOMEN AS IT IS RECOGNIZED FOR ALL IT'S OUTSTANDING CONTRIBUTIONS AND THANK THEM FOR ALL THEY HAVE DONE FOR SO MANY THROUGHOUT THE YEARS, AND, **BE IT**
