ROLE OF COUNTY GOVERNMENT

- Serve as the regional government between federal/state agencies and local municipalities
- Provide vital and essential services to Westchester County residents
- Provide safety and security and emergency protective measures
- Serve as the social safety net for those in need
- Protect drinking water, air quality, manage wastewater treatment
- Manage transportation bus mass transit, regional airport
- Work with businesses, local municipalities and state agencies to create jobs and improve regional economy
- Serve as the administrative arm of NY State for mandated services and advocate for mandate relief

ROLE OF COUNTY LEGISLATORS

- Legislative, policy-making branch of Westchester County
- Co-equal branch with County Executive
- Approve budgets and spending
 - > 12 votes for issuance of bonds
 - ≥9 votes for other items
 - ➤ 12 votes to override County Executive's veto
- Levy County taxes
- Approve appointments of County Executive
- Pass laws, acts and resolutions
- Serve constituents

- All Legislators sworn in by County Clerk Tim Idoni
- Board Chair and Board Vice Chair elected by full BOL on January 8, 2024
 - ➤ Vedat Gashi elected Board Chair District 4
 - ➤ Jose Alvarado elected Board Vice Chair District 17
- Majority and Minority leaders selected by each Caucus
 - ➤ Tyrae Woodson-Samuels District 13 (Majority Leader)
 - ➤ Terry Clements District 11 (Majority Whip)
 - ➤ Margaret Cunzio District 3 (Minority Leader)
 - ➤ James Nolan District 15 (Minority Whip)

2024 BUDGETS

- Operating Budget \$2.44 billion, \$68.61 million increase from 2023
 - County property tax levy flat compared to 2023; fifth year County property tax levy reduced or flat in the Operating Budget
 - Preserve essential services
 - Increased funding for Public Safety, Public Health and Community Mental Health
 - Expand support for nonprofit partners
 - \$5.6 million to continue Project Alliance funding to address the needs of Westchester County residents with behavioral health issues
 - \$56 million for childcare subsidies which includes \$3.3 million for child care scholarships
 - \$1.3 million for food insecurity

2024 BUDGETS (CONT.)

- Capital Budget \$510.7 million, \$170.7 million less than 2023
 - Roads
 - Bridges
 - Buildings
 - Rolling Stock
 - Parking Facilities and Lots
 - Parks
 - \$100 million for affordable housing development
 - \$5 million for EV charging infrastructure grant program for local municipalities

2024 BUDGETS (CONT.)

- Special Districts Budgets \$251.8 million, \$16.2 million increase from 2023
- Tax Levy increased \$14.4 million for all districts or 7.9%

2024 ELECTIONS

- Scarsdale Village Elections (March 19, 2024)
 - ➤ Three Trustees
 - ➤ Village Judge
- April 2, 2024 Presidential Preference Primary
- June 25, 2024 NY Primary Date (Early Voting, June 15 June 23, 2024)
- November 5, 2024 General Election Day (Early Voting, Oct. 26 Nov. 3, 2024)
 - > Presidential Election
 - ➤ Congressional Elections

NEW ELECTION LAW

- Shifts many County and Town Offices from odd-numbered years to evennumbered years
 - ➤ Applies to County Executives, County Legislators, Town Supervisors, Town Boards, Town Clerks
 - ➤ No impact for NY City, Other Cities, Village Elected Officials, County Clerks, District Attorneys, Sheriffs, City Councils, Mayors, many Judicial posts
- No impact of Scarsdale Village Elections
- Transitions start in 2025
 - ➤ Shorten term for those on ballot in 2025
 - ➤ Westchester CE elected in 2025 will have a three year term
 - ➤ Westchester County Legislators will have a one year term (elected in Nov. 2025; serve one year Jan.1 Dec. 31, 2026)

NEW YORK STATE ASSOCIATION OF COUNTIES (NYSAC)

- I was elected NYSAC President-Elect in September 2023
- I will be elected NYSAC President in September 2024 for the one year term that each President serves (Sept. 2024 – Sept. 2025)
- I will be NYSAC President during the 100th anniversary of NYSAC in 2025

SCARSDALE METRO-NORTH STATION UPGRADES

- Station made fully accessible with opening of a second elevator, in an enclosed tower, for travelers on the Grand Central-bound platform.
- Other upgrades of the project include:
 - > An ADA compliant sidewalk from the newly installed elevator at street level.
 - ➤ A new walkway connecting the elevator platform level landing to station platform and overpass.
 - ➤ Benches, leaning bars, new LED lighting, and heaters were installed on the overpass.
 - ➤ Motorcycle parking was rebuilt at street level, as agreed to in the public outreach period prior to the commencement of the project.
