**COMMITTEE ON BUDGET AND APPROPRIATIONS REPORT
CONCERNING THE 2019 COUNTY BUDGET (Final Report)

Honorable Colleagues:

On October 15, 2018, County Executive George Latimer forwarded his proposed 2019 County Capital Budget and on November 9, 2018 forwarded his proposed 2019 County Operating and Special Districts Budgets to the Committee on Budget & Appropriations. The Budget & Appropriations Committee of this Honorable Board has devoted full attention to analyze and discuss them.

The Budget & Appropriations Committee held three hearings on the proposed budget, the first on November 20, 2018, the second on November 27, 2018 and the third and final public hearing, as required by the County's Charter, on Wednesday evening, December 5, 2018 in the Chamber of the County Office Building. The hearings were attended by concerned residents. In addition, the Budget & Appropriations Committee has benefited from the testimony of Commissioners and heads of major departments, as well as from analysis of the proposed budgets by the Citizens' Budget Advisory Committee and by our auditors, which presented their final report to the Budget and Appropriations Committee on Friday, December 7, 2018.

On Monday, December 3, 2018, pursuant to Section 167.81 of the Westchester County Charter as amended by Local Law 8-1994, the Committee on Budget & Appropriations filed a memorandum of proposed additions to the proposed 2019 Budgets.

The Board of Legislators will continue to debate the legally required balanced budgets for 2019. We are committed to continuing to find the balance between investment in our residents, services and infrastructure while stabilizing the tax levy.

Your Committee finds that amounts appropriated in the 2019 County Budgets pursuant to the policies of this Board are for the purposes of performing the operations of the County and providing essential services to County residents. Therefore, the Budget & Appropriations Committee offers the following amendments at this time.
