Core Programs & Functions

- Accept voter registrations in person, centrally and at other locations, or by mail or electronic means;
- Process party enrollment and address changes for registered voters;
- Cancel registrations as necessary due to death, out-of-county moves and incarceration for a felony offense;
- Maintain voter records related to registrations;
- Issue a certification of a voter's voting record on request;
- Accept applications for absentee ballots for all elections and distribute ballots for same;
- Provide nine days of early voting for all primary and general elections;



Core Programs & Functions (continued)

- Recruit, train and employ poll workers to conduct elections;
- Record an official canvass of every election;
- Have custody of, purchase, repair and maintain all voting equipment used to conduct such elections;
- Accept, review and certify petitions for public office, party positions and propositions to be placed on a ballot;
- Maintain maps of political subdivisions and polling places;
- Provide training on election procedures, machine classes and other assistance to school, fire, water and library districts using optical scan voting machines and lend voting machines as needed.

- Absentee Ballots requested: 13,859
- Absentee Ballots returned: 7,384

- Contactless Absentee Ballot Drop-Off
- Social Ambassadors added to manage above during voting



Highlights and Initiatives

- As the pandemic eases, easier to locate polling places.
- On-line training began in 2021 for potential poll workers.
- With census complete, redistricting will result in changes to Election District boundaries requiring updates to maps and voter registration systems.
- Compliance with new Cybersecurity Requirements is due no later than August 1, 2022 (e.g. 14-character passwords for all devices).
