#### Core Programs & Functions

- The Public Works Division provides the County and its residents with the infrastructure required for public health, safety and economic vitality, in addition to working with other departments to ensure they have the apparatus necessary to meet their operational obligations:
  - Work with user departments to plan, design and manage the construction of capital projects.
  - Repair and maintain 136.1 miles of roadway and 165 bridges.
  - Operate County owned and leased buildings to provide a safe, clean and comfortable environment for staff, tenants and the visiting public.
  - Purchase, maintain and repair vehicles and motorized equipment for the use of the county workforce.
- Committed to increasing operational efficiencies by identifying both cost and energy saving measures throughout the year.



### New Initiatives & Highlights

- To continue with our commitments of environmental sustainability and cost savings the Department:
  - Continue to purchase electric vehicles and explore fuel efficient technology for the purchase of other motorized equipment.
  - Move forward with the purchasing and installation of electric vehicle charging stations throughout the County.
  - Partner with NYPA on numerous projects to reduce energy use by installing LED lighting, HVAC upgrades, solar panel installations, window replacements as well as developing a centralized building management system.
- Establish a program for code review and inspection of eligible projects on County property.



# Departmental Response to COVID-19

- The Department has worked diligently to provide a healthy and safe environment for County staff, tenants and the visiting public during the COVID-19 Pandemic:
  - Switched over to cleaning products approved by the CDC and County Health Department to combat the COVID-19 virus.
  - Continues to source, provide and install COVID-19 supplies such as handsfree sanitizer and paper towel dispensers as well as Plexiglas dividers.
  - Installed UV filtration systems and MERV air filters in office ventilation systems to prevent the spread of the COVID-19 virus through the air supply.
  - Continue to work closely with Departments to help reconfigure workspaces to adhere to social distancing guidelines.
  - Developed protocol to sanitize our fleet vehicles for safe use by the County Workforce.
  - Support the set up of COVID-19 pop-up vaccination sites.
