Dear Friends and Neighbors,

It has been an exciting 2018 at the County Board of Legislators. As your legislator, I have worked with my colleagues to pass legislation designed to help protect the health, environment and economic well-being of the county and all its residents.

I'm proud that our first major piece of legislation this term was a law banning gun shows on County-owned property. Gun violence is one of the most pressing issues of our time. County-owned property should never be used as a place for people to obtain firearms or ammunition that could result in the death of county residents by suicide or gun violence.

Protecting the health and welfare of residents is one of county government's most important jobs, and we took a big step in that regard this June when we raised the age for the sale of tobacco and related products from 18 to 21. This bipartisan measure applies both to tobacco and to vaping products for sale in Westchester. In considering the new law, we heard moving testimony from many young people about the explosive growth in use among high schoolers and even middle schoolers of high-nicotine vaping products. These products threaten not only the health of these young people today, but can also create lifelong addictions.

Although as a nation we've made enormous strides in hiring equity, persistent gender- and race-based wage gaps remain, and that is why I am so pleased that we took action to combat these issues by banning questions in hiring about an applicant's prior salary. The law protects women and people of color who often start out in job making less than other job seekers as well as people who may have been laid off or are returning to the job market after a hiatus - maybe to raise children or to care for a family member - ensuring that their new wages will not be tied to old wage levels.

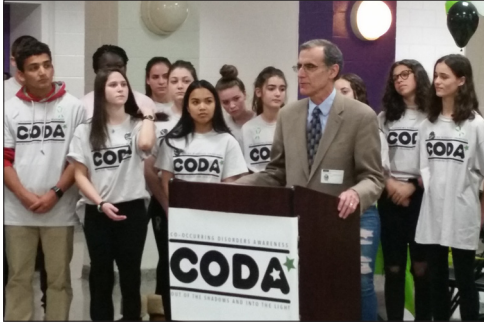

RELAY FOR LIFE



A forecast of rain could not stop Eastchester High School from staging the annual Relay for Life Fundraiser. As a cancer survivor, I walked the first lap of the overnight relay race with other survivors, and then posed with EHS

teacher and Relay for Life advisor Lina Astarita, her family, and County Executive George Latimer. Mrs. Astarita was honored for her work with Habitat for Humanity, a commitment that led her to lend a hand to Relay for Life, the American Cancer Society signature fundraiser.

LATE BREAKING NEWS!

In October we unanimously approved a plan that will bring 76 new units of affordable rental housing to New Rochelle. Under the plan, the county will acquire the land at 14 LeCount Place where developer Wilder Balter Partners is planning a 27-story, 379-unit development, 76 units of which will be affordable housing for people making around half the area median income. The county will pay \$4.18 million for the land and put another \$1.5 million into the expansion of sewer capacity in the area. I am thrilled to support this plan as it goes above and beyond New Rochelle city requirements, with more affordable units than required and with those units being available to people of lower incomes than is required. In supporting developments like this one, which doesn't separate affordable housing from market-rate housing, we don't just help make Westchester a more affordable place to live, we also ensure dignity, respect and equity for all residents, regardless of income.

So proud that Westchester County has become the latest jurisdiction to enact a law providing eligible employees with paid leave for their own medical needs, those of a family member, or other covered reasons. Under this measure, workers can earn one hour of sick time for every 30 hours worked, up to 40 hours per year. The law will cover the more than one-third of workers in Westchester who currently lack any paid sick time and who may face retribution on their jobs if they take time off for illness. This new law is good for Westchester's economy because it puts money in the pockets of hard-working Westchester residents who in the past were forced to choose between the needed day's wages and taking care of an illness – of either themselves, a child or a loved one. The law will take effect on March 30, 2019.
