Challenges for 2024

11

- ▶ On-site security by County Police at the Board's main office during operating hours year-round, to include late and weekend hours, must be addressed.
- ▶ Presidential election year means two Primary Elections.
 - ▶ *Presidential on April 2nd. Note: There will be no early voting on Easter Sunday, March 31st, so all early voting sites will be open an extra hour on the remaining eight days.*
 - ▶ *All other primary contests anticipated to be held on June 25th.*
- ▶ Petitions for the June Primary will most likely be due in early April. By law must be open until midnight on last day to file.
- ▶ New right to petition hearings will require additional staffing hours.

Challenges for 2024 (cont'd.)

- ▶ Field new electronic poll pad technology.

2024 Capital Budget item BEL04 submitted.

- ▶ Replace more than 1,000 aging ballot scanners.

Will submit a proposal to amend BEL04 after January 1st.

- ▶ May have to implement Congressional redistricting -- again -- depending on Court of Appeals decision.

- ▶ May have to implement early voting by mail – a completely new ballot category designed to work around the defeat of no-excuse absentee voting by 55% of the state electorate.
