A47: **Acceptance of Gift - National Insurance Crime Bureau:** Acceptance of a gift in the amount of \$10,000 from the National Insurance Crime Bureau to fund a special project that will help identify and mitigate insurance fraud and vehicle theft in the County. **COMMITTEE REFERRAL: BA – 3/11/08**

A55: **Prisoner Transport IMA-Town of Greenburgh:** Act authorizing the County to enter into an Intermunicipal agreement (IMA) with the Town of Greenburgh in order to provide reimbursement for prisoner transportation to the Westchester County Jail.

A53: **WCHCC Agreement--Medical Services for Residents of Woodfield Cottage:** Proposed Act authorizing the County to enter into an agreement with the Westchester County Health Care Corporation for the term commencing January 1, 2008 and terminating December 31, 2010 whereby WCHCC shall provide in-patient medical services for residents of Woodfield Cottage, the County's secure detention facility. **COMMITTEE REFERRAL: BA/PSS – 3/25/08**

A7: **Capital Budget Amendment:** Proposed Act amending the County 2008 Capital Budget by increasing the appropriations for Capital Project RYON1. [C3] **COMMITTEE REFERRAL: BA/GO – 1/22/08**

A42: **WCHCC Agreement - Monitoring of Service Contracts:** Proposed Act authorizing the County to enter into an agreement with the Westchester County Health Care Corporation (WCHCC) whereby the County will monitor the day to day operations of various service contracts that WCHCC has with outside vendors, will reimburse WCHCC approximately \$1,200,000 for such contracts and will provide approximately \$500,000 in additional services to WCHCC. **COMMITTEE REFERRAL: BA/GO – 3/11/08**
