24) COUNTY EXECUTIVE: WCHCC Agreement-Correctional Facility: Act authorizing the County to enter into an agreement with WCHCC whereby the County shall provide WCHCC with microbiological services for County inmates being provided with medical services pursuant to a separate agreement with WCHCC. **(6/16/08, also B&A)**

25) COUNTY EXECUTIVE: WCHCC Agreement-Microbiological Services: Act authorizing the County to enter into an agreement with WCHCC whereby the County will provide WCHCC with clinical analyses, toxicological, environmental, microbiological, forensic and public health lab services, along with the services of the Medical Examiner's Office and other special projects. **(6/16/08, also B&A)**
