Hello Friends!

Since I took office, a day after the election, on August 10, 2016, I have been very busy sponsoring and passing legislation, supporting local community centers, organizing senior trips, patronizing our friends and local businesses throughout the district and supporting our community through events, meetings and everyday life! More specifically, here is what I have been up to:

TACKLING THE OPIOID CRISIS

Our community faces a truly terrifying opioid crisis, claiming far too many lives. The “Opioid Crisis” does not discriminate, it affects all ages, creeds, races, religions and people.



Mayor Mike Spano and I hosted a Press Conference regarding the accessibility and convenience of Medical Drop-Boxes around our area.

As Chair of the Seniors committee I’m working with all of our government partners in Bi-Partisanship for the benefit and well-being of the people. The Opioid Crisis disproportionately affects our senior population.

The Yonkers Police Department (YPD) has agreed to bring these Medical Drop-Boxes to 6 seniors centers, throughout the year, for the disposal of excessive medication.

These Drop-Boxes will help people dispose of outdated and excess medica-

tion, preventing theft, misuse, abuse and even over-dose or death.

LEGISLATION BANNING SYNTHETIC MARIJUANA - “K2”

It is a privilege and honor that my first bill sponsored, “Banning of Synthetic Marijuana” has passed, in bi-partisanship.

Synthetic Marijuana, also known as K2, Spice, Scooby-Snax, AK-47, along with several other nicknames, has had devastating consequences, causing people to hallucinate, suffer horrible seizures, act violently and ingestion has even led to death.

Our Local Law now allows the Department of Health to coordinate with the Department of Public Safety for inspections, seizures and enforcement, including the implementation of fines and even jail time.



This bill gives our law enforcement the tools and instruments necessary to successfully fight the horrific epidemic of

“Synthetic Marijuana.”

My motto from the outset has been, “It’s Not About Me, It’s About Us,” and that includes the safety and protection of all!

SENIORS COMMITTEE



As Chair of the Seniors Committee, we have worked closely to follow the example set by living-legend Bernice Spreckman. Bernice and I similarly share the mindset of people over politics!

My office has hosted several senior trips including traveling to the Jacob Burns Film Center, Salute to Seniors, Legislative Speak-Out, Older Americans Act Advisory Council and the Senior Summer Show.

We’re also tackling the Opioid Crisis and over-pricing of prescription drugs on behalf of senior citizens, while fighting Senior Isolationism. Keeping our seniors active, healthy and social is the best way to fight isolationism, which negatively affects 1 in 3 seniors today. If you or some-

AISLING IRISH COMMUNITY & CULTURAL CENTER



The Aisling Irish Community & Cultural Center was established in 1996, with its principle goal of assisting Irish Immigrants in their transition to life in America. Contained within the Center is a senior program known as the Young-at-Heart Senior Club, which has over 250 members. This Club seeks to keep our seniors socialized through a variety of energizing and enjoyable programs and activities!

My office worked diligently to deliver \$15,000 in allocated community funds to the Young-at-Heart Senior Club of the Aisling Irish Community & Cultural Center. The community funds will be used for lunches, health screenings, computer classes, educational programs and so much more.

HISPANIC AFFAIRS TASK FORCE COMMUNITY FORUM



The Hispanic Affairs Task Force serves as a liaison between the local government and community; it plays a pivotal role in planning and executing Hispanic community events, education and outreach.

Force, I'm happy to report that we hosted our first Hispanic Community Forum. The Forum was designed to inform the Hispanic community of options Westchester County offers to help in services and quality of life, but also hear the most pressing issues from the people themselves. We listened to the Hispanic Community with their most pressing issues and continue to act as a liaison between our local government and our community.

NORTH-60

Fellow members of the Legislature successfully voted and passed a local law, which entered into a lease agreement with Fareri Associates regarding a large-scale development project, known as North-60.

North-60 is a \$1.2 billion-dollar project, which is forecasted to create 8,000 permanent jobs and 4,000 construction jobs. North-60 is also projected to have \$9 million dollars per year in new real estate property taxes and \$7 million dollars of rental income to the County.



The complex will contain approximately 3 million square feet of developed space, utilizing 46% of the land, including Bio-Technology/Research Labs (2,252,600 sq. ft.), Medical Offices (400,000 sq. ft.), Retail Shopping (114,000 sq. ft.), Neighborhood Shopping (100,000 sq. ft.), a Hotel (100,000 sq. ft.), and a Living Science Center (34,000 sq. ft.).

North-60 is a County-owned 60-acre parcel of land, located on the Grasslands Reservation in Valhalla, New York, adjacent to Westchester Medical Center, New York Medical College, Touro Dental College and Westchester Community College.

Westchester County is also known as the Golden Apple, hopefully it will also be known as Bio-Chester in the near future.

NEIGHBORHOOD ASSOCIATION (FNA) MEETING



The Fleetwood Neighborhood Association (FNA) is comprised of residents of Mt. Vernon committed to the vitality of their community. Members meet with local and state officials to discuss the quality of life in Fleetwood.

At the recent meeting of Fleetwood Neighborhood Association (FNA), we discussed the delivery of funds to the Mount Vernon Youth Basketball Program. I proudly worked in a bi-partisan manner to deliver over \$20,000 in funds to at-risk-youth in the City of Mount Vernon!

Fleetwood is one of the most historically significant neighborhoods in Westchester, as well as the cornerstone of our local community and the beating heart of Mount Vernon. Our children are our future and I am committed to providing the best possible quality of life to all in the 14th Legislative District!

As for a brief history lesson, before 1850, Fleetwood got its name because it was the name of a farm owned by Jonas Farrington, which survived through present day.
