He is currently the Director of Capital Projects, where he is responsible of Capital Groups, and sets up the entire Capital Program for all the county departments, and he has served as electric designer for the past 25 years for the County.

The members were satisfied with his years of electrical and design experience with the County as he will be an asset to this Board and thanked him for his time to serve as well.

**Steven A. Ecklund:** Is a resident of Tuckahoe, and has been appointed by the County Executive to serve as the Municipal Representative member of the Electrical Licensing Board, for a term to expire December 31, 2014. He replaces the expired term of William Hanauer. He is the 4<sup>th</sup> generation resident to serve as Village Trustee, his great-grandfather was the 1<sup>st</sup> in 1914.
